RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, ON BEHALF OF THE CITY OF OAKLAND, TO ACCEPT AND APPROPRIATE GRANT FUNDS IN AN AMOUNT NOT TO EXCEED TWO HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$225,000) FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, COMMUNITY CAPACITY DEVELOPMENT OFFICE, FOR FIFTH YEAR PROGRAM IMPLEMENTATION OF THE WEST OAKLAND WEED AND SEED INITIATIVE, AND APPROPRIATE SAID FUNDS TO THE POLICE DEPARTMENT

WHEREAS, it is anticipated that grant funds totaling up to \$225,000 will be received from the U.S. Department of Justice, Office of Justice Programs, Community Capacity Development Office, Weed and Seed Grant Program in support of fifth year program implementation of the West Oakland Weed and Seed Initiative (WOWSI) in the Police Department; and

WHEREAS, Weed and Seed grant funds are utilized to promote a community-based, multiagency partnership approach to law enforcement, crime prevention, and neighborhood restoration; and

WHEREAS, funding for the West Oakland Weed and Seed Initiative will assist in the Police Department's goals of controlling violent and drug-related crime in targeted high-crime neighborhoods; and

WHEREAS, the proposed grant does not allow for indirect costs (Central Services Overhead) charges in the amount of \$13,789, and the Department requests a waiver of said charges; and

WHEREAS, the City Council previously authorized acceptance of similar grant funds by Resolution No. 78557 C.M.S. dated May 18, 2004, Resolution No. 78188 dated November 4, 2003, and Resolution No. 77554 C.M.S. dated December 3, 2002; now, therefore be it

RESOLVED: That the City Council hereby authorizes the City Administrator or her designee to accept and appropriate a grant in an amount not to exceed \$225,000 from the U.S. Department of Justice, Office of Justice Programs, Community Capacity Development Office, Weed and Seed Grant Program, to be allocated to the Federal Grant Fund: 2112, Police Neighborhood Services Org.: 105320, Patrol Program: PS11, in a Project Account to be determined; and be it

FURTHER RESOLVED: That Central Services Overhead costs of \$13,789 are hereby waived; and be it

FURTHER RESOLVED: That grant funds received for the Weed and Seed Grant program shall not be used to supplant expenditures controlled by the City of Oakland; and be it
