

**RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF KIRIN
BAWA AND REAPPOINTMENT OF NICOLAS HEIDORN TO THE
BUDGET ADVISORY COMMITTEE**

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Resolution No. 74826 C.M.S., adopted March 2, 1999, creates the Budget Advisory Committee to provide fiscal management in an advisory capacity to the City Council; and

WHEREAS, the Budget Advisory Committee consists of 15 members, one (1) apiece recommended by each of the eight City Councilmembers, one (1) appointed by the Mayor to act as Chairperson, three (3) appointed by the Mayor from a list of 12 recommendations from the Chamber of Commerce, two (2) recommended by the Chairperson of the Finance and Management Committee, and one (1) recommended by the Chairperson of the Community and Economic Committee, each serving no more than two consecutive two-year terms and each subject to the approval of the City Council; and

WHEREAS, the Honorable Mayor Jean Quan has appointed Kirin Bawa to serve as Mayoral appointment to the Committee and reappointed Nicolas Heidorn on the recommendation of Councilmember Kernighan as City Council District 2 representative, each to serve a two year term subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Kirin Bawa to a two-year term beginning May 26, 2011 and ending May 25, 2013, filling the seat previously held by

Barbara Armstrong, and Nicolas C. Heidorn to a two year term beginning February 25, 2012 and ending February 24, 2014, filling the seat he previously held.
