

RESOLUTION APPOINTING DINAH BENSON AND REAPPOINTING DELORES MCDONOUGH AS MEMBERS OF THE WILDFIRE PREVENTION AND ASSESSMENT DISTRICT ADVISORY BOARD

Whereas, Ordinance No. 12556 creates the Wildfire Prevention Assessment District Advisory Board, which provides oversight and program recommendations for the Assessment District, and play a key role in the continued implementation of vegetation management programs and the development of fuel management strategies; and

Whereas, Ordinance No. 12556 specifies that the Mayor shall appoint two (2) constituents who live in the Assessment District, one of whom shall be a firefighter by profession, to serve as follows: Initially, one appointee shall serve for a term of two years (through June 30,2006); the second appointee shall serve for a term or three years (through June 30, 2007). Thereafter, each subsequent appointment shall be for a term of two years; and

Whereas, Ordinance No. 12556 specifies that the At-Large Councilmember shall appoint one (1) constituent who lives in the Assessment District, and who shall serve for a term of two years (through June 30, 2006). Thereafter, each subsequent appointment shall be for a term of two years; and

Whereas, Ordinance No. 12556 specifies that each of the four (4) Wildfire Prevention Assessment District Council members shall appoint two (2) constituents each, who live in the Assessment District to serve as follows: Initially, one appointee shall serve for a term of two years (through June 30, 2006); the second appointee shall serve for a term or three years (through June 30, 2007). Thereafter, each subsequent appointment shall be for a term of two years; and therefore be it

In 2000, then Mayor of Oakland Jerry Brown appointed Dinah to the City of Oakland's Parks and Recreation Commission where she was the Commission's liaison to the Dunsmuir Hellman Historic Estate.

Dinah Benson has a B.A. in Art History from the University of Michigan, she also holds a Juris Doctorate from Southwestern University of School of Law. While an active member of the California Bar Association, Dinah specialized in labor litigation.

Dinah's involvement in local politics spans over forty-years, from when she became active in the incorporation of the City of Irvine and was instrumental in creating the City's first Parks and Recreation Department.
