INTRODUCED BY COUNCILMEMBER DESLEY BROOKS

RESOLUTION AUTHORIZING COUNCILMEMBER DESLEY BROOKS TO TRAVEL TO DENVER, COLORADO TO ATTEND THE NATIONAL LEAGUE OF CITIES CONGRESS OF CITIES AND EXPOSITION NOVEMBER 30, 2010 TO DECEMBER 4, 2010

WHEREAS, Councilmember Desley Brooks wishes to represent the City of Oakland at the National League of Cities Congress of Cities and Exposition in Denver, Colorado from November 30, 2010 to December 4, 2010; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate in agenda reports whether City funds will be used when travel involves airline transportation and lodging, and shall provide in agenda reports an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation (including airfare and taxis) is \$445.00, of lodging is \$870.00 for four nights, of per diem is \$280.00 for five days, and of conference registration fees is \$515.00; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from the City Council Contingency Project funds; and

WHEREAS, Councilmember Desley Brooks seeks Council approval of the fore mentioned estimated costs to travel to Denver, Colorado to attend the National League of Cities Congress of Cities and Exposition, November 30, 2010 to December 4, 2010; now, therefore, be it

RESOLVED: that all expenses incurred for said travel are hereby authorized.
