RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF KEVIN ALAN MANN TO THE COMMISSION ON PERSONS WITH DISABILITIES

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No 9968 C.M.S., adopted August 5, 1980, and amended by Ordinance No. 11864 C.M.S, adopted March 12, 1996, created the Commission on Persons with Disabilities to address issues germane to accessibility, services and civil rights for persons with disabilities; and

WHEREAS, the Commission on Persons with Disabilities consists of fifteen (15) members serving three year staggered terms with no more than two consecutive terms, and 51% of Commission members must be disabled persons; and

WHEREAS, the Honorable Mayor Jean Quan has appointed Kevin Alan Mann to serve a three year term subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Kevin Alan Mann to the Commission on Persons with Disabilities for a three-year term beginning September 3, 2010 and ending September 2, 2013, filling the seat previously held by Merlin Nw.
