RE: Annual Informational Report on City-Funded Event Tables Purchased During Fiscal Year 2009-2010

### SUMMARY

On July 17, 2007, City Council Resolution No. 80777 C.M.S. and Oakland Redevelopment Agency (ORA) Resolution No. 2007-066 were adopted establishing rules and reporting requirements to enhance fiscal accountability and transparency within the City. The resolutions established requirements to publish and make available to the public an annual report detailing event tables purchased and paid for by the City of Oakland and the Oakland Redevelopment Agency. All such event tables purchased by City officials and employees between July 1, 2009 and June 30, 2010 are detailed in *Attachment A* to this report.

### FISCAL IMPACT

This is an informational report and there are is no fiscal impacts. During Fiscal Year 2009-10, City-wide purchases of event tables amounted to \$400 across all funds. This represents a 20.8 percent reduction from Fiscal Year 2008-09 City-wide expenditures for event tables.

### BACKGROUND

Resolution No. 80777 C.M.S. and ORA Resolution No. 2007-066 established an annual requirement to publish a report identifying all purchases of event tables paid by City and Oakland Redevelopment Agency funds [either by General Fund (1010) or non-1010 funding] to the extent allowable in accordance with grant provisions; including the payee and amounts paid. Event tables at community events, seminars, conventions or conferences are purchased and established for the purpose of disseminating or promoting information on health and wellness, environment concerns, the City's business environment and other positive community aspects.

### **KEY ISSUES AND IMPACTS**

As detailed in *Attachment A* to this report, the sources of funding for the purchase of event tables were from Coliseum Operations (Fund 9450). The Event table was purchased for the Airport Area Business Association 20<sup>th</sup> Annual Holiday Auction Celebration and Luncheon. There was a 20.8 percent (or \$105) decrease in events tables purchased from the FY 08-09 expenditures. Increased managerial oversight and funding limitations has resulted in a continued decrease in event table purchases over the years.
