### **RE: A REPORT CALCULATING THE OAKLAND CITY AUDITOR'S SALARY IN CONFORMITY WITH THE OAKLAND CITY CHARTER**

Dear President Reid and Members of the Council:

### PURPOSE AND SCOPE

The Oakland City Charter, Article IV, Section 403, states that the Council shall set the salary for the City Auditor as follows:

"The salary of the office shall be set by the Council, which shall be not less than 70% nor more than 90% of the average salaries of City Auditors of California cities within the three immediate higher and the three immediate lower cities in population to Oakland, and may not be reduced during the City Auditor's term of office, except as a part of a general reduction of salaries for all officers and employees in the same amount or proportion."

### SALARY SURVEY

The City Auditors' salary in the six cities was obtained by contacting the personnel department, City Clerk's Office, City Manager's Office or website of each city. We were able to retrieve actual City Auditor salaries from each City with an established City Auditor's Office.

### **CONCLUSION**

Under the prescribed procedures of Article IV, Section 403, we have calculated the salary range for the City of Oakland Auditor to be within a low \$129,500 and a high of \$166,500. The City Auditor's current salary was approved by City Council resolution in 2007 and set at \$145,140.38 per annum, within a range of \$118,137.92 to \$151,891.00.
