DOLLARS (\$72,000), AND AUTHORIZING AN OPTION TO RENEW FOR ONE

YEAR UNTIL May 31, 2013 FOR AN ADDITIONAL SEVENTY TWO

THOUSAND DOLLARS (\$72,000), FOR A TOTAL AMOUNT NOT-TO-EXCEED

(\$144,000) FOR THE ENTIRE TERM OF THE AGREEMENT.

SUMMARY

At the Rules Committee meeting on May 19, 2011, the Committee requested that the Mayor's office provide additional information regarding the experience and qualifications of the firms that submitted proposals to become the City's federal legislative lobbyist.

KEY ISSUES AND IMPACTS

On February 9, 2011, the City of Oakland issued an RFP to engage a Federal lobbyist for the City of Oakland.

The firms that submitted proposals included: Akerman Senterfitt LLP, The Crane Group, Holland & Knight, Polsinelli Shughart, Russ Reid, and Townsend Public Affairs.

The Mayor's office established a panel of four to review the proposals. The members of the panel included Council President Larry Reid, John Bailey, Executive Director of the Workforce Investment Board, Ester Gulli, Deputy Director, Government and Community Relations Office of the Chancellor University of California, Berkeley, and Bob Brauer, Former Director of Intergovernmental Affairs to Oakland Mayor Ron Dellums.

The panel selected four firms to interview based on the quality of the written proposals. The firms selected for an interview included: Akerman Senterfitt LLP, The Crane Group, Holland & Knight and Townsend Public Affairs.

In evaluating the firms, the panel considered the experience of the firms, their qualifications, the organization of their staff, the approach proposed to the City, the participation of local & small

Based on the evaluation criteria mentioned above, Townsend Public Affairs was selected unanimously as the best firm to represent the City of Oakland as its federal lobbyist.
