INTRODUCED BY VICE MAYOR ANNIE CAMPBELL WASHINGTON

**RESOLUTION AMENDING RESOLUTION NO. 85344 C.M.S., WHICH AUTHORIZED A GRANT OF \$13,600 FROM VICE MAYOR CAMPBELL WASHINGTON'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS FOR TWO MURALS ON THE WALLS OF KING'S COFFEE SHOP AT 3000 38<sup>TH</sup> AVENUE IN OAKLAND, TO CHANGE THE NAME OF THE GRANTEE TO XOCHITL N. GUERRERO**

**WHEREAS**, on June 27, 2013, the City Council adopted a budget that set aside Graffiti abatement funds for Murals and Green Walls in the amount of \$50,000 for each council member to address graffiti within their districts; and

**WHEREAS**, the two walls on King's Coffee Shop are currently in a state of graffiti blight; and

**WHEREAS**, on January 6, 2015 pursuant to Resolution No. 85344 C.M.S. the City Council authorized a grant of \$13,600 from Vice Mayor Campbell Washington's graffiti abatement mural funds to Corum, LLC for two murals on the walls of King's Coffee Shop; and

**WHEREAS**, Vice Mayor Campbell Washington wishes to grant the funds to the artist, Xochitl N. Guerrero, to paint the murals, instead of Corum, LLC; and

**WHEREAS**, in conformance with City requirements Xochitl N. Guerrero will provide documentation for the use of the Vice Mayor's Graffiti Abatement Mural and Green Wall funds and for use of the proposed mural site; now, therefore, be it

**RESOLVED:** That Resolution No. 85344 C.M.S., which authorized a grant of \$13,600 from Vice Mayor Campbell Washington's graffiti abatement mural funds to Corum, LLC for two murals on the walls of King's Coffee Shop, is hereby amended to change the name of the grantee to Xochitl N. Guerrero; and be it

**FURTHER RESOLVED:** That the City Council authorizes the use of \$13,600 from Vice Mayor Annie Campbell Washington's Graffiti Abatement Mural and Green Wall funds for a grant to Xochitl N. Guerrero for two murals on the wall of King's Coffee Shop at 3000 38<sup>th</sup> avenue in Oakland; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to execute a grant agreement with Xochitl N. Guerrero in the amount of \$13,600 for the above purpose, subject to approval as to form and legality by the City Attorney.
