INTRODUCED BY VICE MAYOR REBECCA KAPLAN

RESOLUTION IN SUPPORT OF THE LITIGATION, BROUGHT BY SAN FRANCISCO DISTRICT ATTORNEY CHESA BOUDIN, AGAINST GHOST GUN MANUFACTURERS TO FIGHT AGAINST THE INCREASING VIOLENCE AND DEATH THAT THESE UNTRACEABLE GUNS HAVE CAUSED IN THE CITY OF OAKLAND

WHEREAS, on August 18, 2021, San Francisco District Attorney Chesa Boudin filed a civil lawsuit in San Francisco Superior Court against three "ghost gun" manufacturers; and

WHEREAS, the lawsuit seeks a court order that would bar the companies from shipping their products in California; and

WHEREAS, there has been an upward trend of gun violence in Oakland since the start of the COVID-19 pandemic, and especially over recent months; and

WHEREAS, illegal gun dealers and users are supplied by the ease of purchasing and assembly of ghost guns and their lack of traceability; and

WHEREAS, "Ghost Guns" are increasingly being sold, bought, and used in California, and, according to the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), account for 30% of guns recovered in California in 2019; and

WHEREAS, "Ghost Gun" manufacturers do not follow gun safety regulations such as marking their product with a serial number, background checks, or requiring a user to have a gun license; and

WHEREAS, "Ghost Guns", once assembled, looks, feels, and functions like a traditional gun, whether a handgun or assault weapon; and

WHEREAS, the entire system of gun safety laws and regulations are undermined by "ghost gun" manufacturing companies, who are profiting from the violence and harm in our community; and

WHEREAS, in order to protect public safety it is vitally important that such "ghost guns" be controlled and regulated no less fully than other types of guns, as they are no less of a threat to the public; and

WHEREAS, it is important that the City of Oakland support the fight to stop the sale and distribution of unregulated firearms that have caused death and trauma in our City; now, therefore, be it

RESOLVED: That the Oakland City Council declares its support for San Francisco District Attorney Chesa Boudin's lawsuit against "ghost gun" manufacturers to fight against the increasing violence and death that these untraceable guns have caused in the city of Oakland.


