PROCESS FOR THE CULTURAL AFFAIRS DIVISION

SUMMARY

This report provides additional information on the appointment process and selection of members to serve on the Cultural Affairs Commission.

BACKGROUND

On August 5, 1980, the City Council passed Ordinance No. 9969 C.M.S., creating the Oakland Arts Council. The Cultural Affairs Commission, formerly the Oakland Arts Council, was established pursuant to Section 601 of the City Charter effective May 1, 1991 by Ordinance No. 11323 C.M.S. After operating for over 30 years, the Cultural Affairs Commission went on a hiatus in 2011 due to their inability to achieve a quorum on a regular basis and conduct business in a timely fashion.

On July 10, 2018, the City Council passed Resolution No. 87271 C.M.S., adopting the Cultural Plan, "Belonging in Oakland: A Cultural Development Plan", which articulated the City's cultural priorities and provides a policy framework and that will strengthen and advance Oakland's art and cultural sector. During the cultural planning process, there was strong interest from the community to strengthen City support for the cultural sector and to re-establish the Cultural Affairs Commission as a demonstration of commitment to community requests ("Belonging in Oakland: A Cultural Development Plan", p. 106-107).

On June 13, 2019, the City Council passed Ordinance No. 13561 C.M.S. which reestablished the Cultural Affairs Commission as an advisory body of eleven members appointed by the Mayor, with City Council approval. The primary purpose of the Commission is to advise the Mayor, City Council, City Administrator, and the Cultural Affairs Manager on all matters affecting cultural development in the community and to develop and foster support for the arts and humanities throughout the city.

Per Ordinance No. 13561 C.M.S approved on June 13, 2019, Section 6. Membership and Section 7. Appointment the specific requirements for the eleven Cultural Affairs Commission members are:

SECTION 6. MEMBERSHIP

a. The Commission shall consist of eleven (11) members, who shall serve without compensation. Appointments shall be made pursuant to Section 601 of the Charter.

- b. Six (6) members shall constitute a quorum, and any decision by the Commission shall require a majority of those members present.
- c. To the extent practicable, appointments to the Cultural Affairs Commission shall be made using the guiding principles of cultural equity to help reflect the diversity of the City.
- d. To the extent practicable, appointments to the Cultural Affairs Commission shall reflect the geographical diversity of the City.
- e. In making appointments to the Cultural Affairs Commission, the Mayor shall consider recommendations for appointments offered by each Councilmember. Councilmembers must submit recommendations to the Mayor for consideration at least 30 days prior to expiration of an existing Commission member's term.
- f. The Commission shall recommend to the Mayor at least one (1) member for appointment.
- g. The Commission shall include at least one (1) member of the Public Art Advisory Committee (PAAC) to be selected by the Mayor and appointed pursuant to Section 601 of the Charter. If the PAAC member selected does not agree to accept an appointment, the Mayor may appointment another member pursuant to Section 601 of the Charter.

SECTION 7. APPOINTMENT

a. Terms of Appointment. All terms shall commence on October 1 and end on September 30. For the initial appointment only, four (4) members shall be appointed for a three-year term, four (4) members shall be appointed for a two-year term, and three (3) members shall be appointed for a one-year term. Thereafter, all appointments shall be for three (3) years, except that an appointment made to fill a vacancy created by the premature departure of a Commission Member shall be for the unexpired portion of the departed Commission Member's term only.

APPOINTMENT PROCESS

The City received 93 applications to serve on the Cultural Affairs Commission. Councilmembers were asked to submit recommendations to the Mayor for appointments. Interviews were conducted to learn more about the finalists before the final selection was made.

The nominated group of eleven commissioners complies with the legal requirement of Ordinance No.1356 CM.S.. These individuals represent all seven districts and are community members who have a deep connection to Oakland through their personal and professional experiences. They are dancers, musicians, curators, cultural strategists, educators, non-profit administrators, lawyers, publishers, writers, storytellers, community organizers, and civil engineers.

Together, they will make strong advocates and ambassadors for arts and culture in Oakland. See Attachment A for applications and resumes.

I am a storyteller. I am a poet. I am a stepmother to two and birthmother to one, each born and growing roots within Oakland, California. I am a social entrepreneur and cultural creator whose commitment is to an embodied ethic of justice and belonging, wherever I am invited in. As a child of voluntary immigrants as New World and Old Country—I understand the particular experience of being neither here nor there; of being immigrant and poor, woman and artist of color, Hip Hop and intellectual, spiritual and revolutionary. Like many of those I've had the privilege of serving and speaking with during my tenure as an artist and organizer, I, too, have felt trapped between the Hyphen that says brown skin is culturally, here. And not. My nuanced and complex story is my gift. And I believe it is what calls me to this moment of service. I believe deeply that it is my civic duty to throw my name in the hat to help steward our city's vision for more vibrant communities and robust cultural movements. As an artist, racial justice educator and healing-informed facilitator with an international network, I have travelled to cities, neighborhoods and institutions across many dividing lines. I have mentored and been mentored, learned about program design and help build programs and whole organizations with young musicians, muralists, dancers, spoken word poets and community arts leaders in Guam, India, Pine Ridge (South Dakota), Miami, Anchorage, Honolulu, Baltimore, Philadelphia, Detroit and Flint. As a professional trainer and emerging businesswoman, I have advised on cultural strategies with educational leaders at Harvard University's Graduate School of Education, neuroscientists at Stanford University, members of the original cast of Hamilton: An American Musical, as well as clinical therapists engaged in post-modern, narrative therapy. I have worked closely with dozens of Oakland artist, strategists and cultural institutions to create, sustain and strengthen local creative communities of practice. I've hosted conversations with renown cultural historians and social innovators of our time including Jeff Chang, Samina Ali, Daveed Diggs, Laurene Powell Jobbs, Roberta Uno, Yosimar Reyes, Natalie Basile, Marc Bamuthi Joseph, Chinaka Hodge and Deborah Santana. I am a native of Oakland, California with Southern roots in Louisiana, Arkansas, and Mississippi. I have been active in community arts, organizing and presenting for over 20 years. I'm excited to be considered for the role of Commissioner for the City of Oakland's Arts

I was first introduced to African drum and dance as a child in Oakland's Mosswood Park. While tagging along with my mom, I heard the thunder from an African drum and dance class. I saw people were dancing and the room was filled with joy -- the joy and rhythms that would remain in my subconscious for many years. Coincidentally, this class was led by dance legend Ruth Beckford.

After graduation from Skyline High School, i attended San Diego State University and was introduced to and began taking modern dance classes by staff professor and Alvin Ailey's lead dancer, the late Dr. Danny Scarborough. I rehearsed and performed with the class but never considered the Arts as a profession.

I relocated to Atlanta, Georgia to complete my undergraduate education at Clark Atlanta University and this is where I was reunited with the drums that had inspired my subconscious for decades. I began taking African dance with the Uhuru Dancers, Maya & Oginga and Waleed. I quickly became one of the premier dancers and met my most influential West African Dance instructor, Alseny Soumah from Conakry, Guinea.

After 10 years in Atlanta, I returned to Oakland and was introduced to Brazilian dance and joined the award winning Carnaval group, Fogo Na Roupa, led by Mestre Carlos Aceituno and Regina Calloway.

Within one year in 2001, I competed and won King of San Francisco Carnaval. I continued to dance Brazilian dance exclusively with Mestre Carlos and Fogo until 2006, when in the Fall, Mestre

Carlos, at age 46, suffered tragic heart failure and unexpectedly transcended to a higher plane.

Four years later, in 2010 i founded SambaFunk! and began teaching Brasilian Carnaval dance.

Since the founding of SambaFunk!, i've remained active in the Arts community beyond Carnaval, as an artist, producer and advocate invoking the Arts in relevant political and social

justice causes. I've traveled, studied and performed Brazilian dance and drum in Brazil, Canada, France and Guinea West Africa. As a student and instructor, I continue to learn the internal connections of African centered dance, movement, rhythms and spiritual psychology.

RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF ROY CHAN, JENNIFER EASTON, MICHAEL ORANGE, VANESSA WHANG, KEVIN CHOICE, J.K. FOWLER, MICHELLE LEE, DIANE SANCHEZ, RICHARD RAYA, CHARMIN ROUNDTREE-BAAQEE, AND THEO AYTCHAN WILLIAMS TO THE CULTURAL AFFAIRS COMMISSION

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 13561 C.M.S. re-establishes the Cultural Affairs Commission as a professionally qualified citizen committee responsible for advising the City regarding its public art program, and provides that the Public Art Advisory Committee has nine members; and

WHEREAS, Ordinance 13561 C.M.S provides that all terms shall commence on October 1 and end on September 30. For the initial appointment only, four (4) members shall be appointed for a three-year term, four (4) members shall be appointed for a two-year term, and three (3) members shall be appointed for a one-year term. Thereafter, all appointments shall be for three (3) years, except that an appointment made to fill a vacancy created by the premature departure of a Commission Member shall be for the unexpired portion of the departed Commission Member's term only. Commencing with the effective date of this Ordinance, no person shall be appointed to serve as a member of the Cultural Affairs Commission for more than two (2) consecutive three (3) year terms plus any initial term of less than two years; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed Roy Chan, Jennifer Easton, Michael Orange, and Vanessa Whang to serve a three (3) year term on the Cultural Affairs Commission; and Kevin Choice, J.K. Fowler, Michelle Lee, and Diane Sanchez to serve a two (2) year term on the Cultural Affairs Commission; and Richard Raya, Charmin Roundtree-Baaqee, and Theo Aytchan Williams to serve a one (1) year term on the Cultural Affairs; now therefore, be it,

RESOLVED: That the City Council hereby confirms the Mayor's appointment of:

Roy Chan, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2022.

Jennifer Easton, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2022.

Michael Orange, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2022.

Vanessa Whang, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2022.

Kevin Choice, to serve a two-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2021.

J.K. Fowler, to serve a two-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2021.

Michelle Lee, to serve a two-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2021.

Diane Sanchez, to serve a two-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2021.

Richard Raya, to serve a one-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2020.

Charmin Roundtree-Baaqee, to serve a one-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2020.

Theo Aytchan Williams, to serve a one-year term on the Cultural Affairs Commission beginning October 1, 2019 and ending September 30, 2020.
