RESOLUTION AUTHORIZING THE CITY MANAGER TO INCREASE THE CONTRACT WITH OAKLAND CONSULTING GROUP, INC. FROM THIRTY-THREE THOUSAND (\$33,000) TO ONE HUNDRED - SIX THOUSAND (\$106,000) FOR TECHNICAL PROGRAMMING SERVICES RELATED TC FAST FORMULAS, EMPLOYEE / EMPLOYER CONTRIBUTIONS TO THE PUBLIC EMPLOYERS RETIREMENT SYSTEM "PERS" AND POLICE AND FIRE RETIREMENT SYSTEM "PFRS" CONTRIBUTIONS

WHEREAS, Oakland Consulting Group Inc. has been essential by providing technical programming assistance to the City of Oakland's Oracle business system applications; and

WHEREAS, the Office of Personnel wishes to meet the agreement between Local 790, Local 21 and the City of Oakland; and

WHEREAS, the Office of Personnel needs to develop new "fast formulas" for Payroll and Human Resource operations; and

WHEREAS, the Office of Personnel needs to continue reporting employee and employer "PERS" and "PFRS" contributions; and

WHEREAS, the City requires highly experienced and skilled technical programming assistance with specific knowledge of the Oracle Payroll and Human Resource applications to perform said tasks; and

WHEREAS, City staff has interviewed and selected Oakland Consulting Group Inc., a qualified local Oakland vendor with personnel qualified to meet our requirements; and

WHEREAS, the consultant has demonstrated qualifications and technical experience to perform such services for the City; and,

WHEREAS, City Council finds that the services provided pursuant to the agreement authorized hereunder are of a technical nature; and,

WHEREAS, the City Council finds that the services provided are temporary in nature; and,

WHEREAS, Council finds that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; and,

WHEREAS, the calling for bids would serve no useful purpose; now, therefore, be it

RESOLVED: That the City Council hereby authorizes the City Manager or his designee to amend the professional services contract between the City of Oakland and Oakland Consulting Group Inc. to add an additional seventy-three thousand dollars (\$73,000) for a total contract amount not to exceed one hundred and six thousand \$106,000 for consulting services related to New Pay elements and reporting employee and employer "PERS" and "PFRS" contributions; and be it

FURTHER RESOLVED: That the call for bids is not in the best interest of the City of Oakland.
