

**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO NEGOTIATE AND EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH CORK MARCHESCHI TO CREATE A PUBLIC ART PROJECT AT STUDIO ONE ART CENTER IN AN AMOUNT NOT TO EXCEED ONE HUNDRED THOUSAND DOLLARS (\$100,000)**

**WHEREAS**, the City of Oakland is renovating and rehabilitating Studio One Art Center in Oakland's Temescal neighborhood; and

**WHEREAS**, in February 1989, the City of Oakland adopted a Public Art Ordinance (no. 11086 C.M.S.) authorizing the allocation of 1.5% of City capital improvement project costs for the commissioning of public artwork; and

**WHEREAS**, it is the intent of the Public Art Ordinance to provide a means for the City to commission artists to create artwork, which enlivens, enhances, and enriches the visual environment of the City of Oakland; and

**WHEREAS**, on March 25, May 27 and September 15, 2005, an eleven-member selection panel, consisting of regional artists, community members, and project representatives met to select an artist and to approve a public art proposal for the Studio One Art Center, and unanimously recommended funding of a proposal by artist Cork Marcheschi; and

**WHEREAS**, on October 3, 2005 the Public Art Advisory Committee voted to accept the recommendation of the selection panel, and on October 24, 2005 the Cultural Affairs Commission voted to approve artist Cork Marcheschi's design proposal for the Studio One Art Center Public Art Project; and

**WHEREAS**, the City of Oakland finds that this contract is professional in nature and will not result in a loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

**RESOLVED**, that the City Council hereby authorizes the City Administrator to negotiate and execute a professional services agreement with Cork Marcheschi in an amount not to exceed one hundred thousand dollars from the City's Public Art Project Account for Studio One (Fund 5320, Account 53719, Project C244720) for the design, fabrication and installation of a public art project at the Studio One Art Center; and be it

**FURTHER RESOLVED**, that the City Administrator is hereby authorized to execute any amendments or modifications of said contract within the limitations of the project specifications; and be it

**FURTHER RESOLVED**, that the agreement will be reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk.
