WHEREAS, Herb Chan worked in the OPR Sports and Aquatics Unit from 1996 to 1999 and coordinated Tennis and Adult Sports programs; and

WHEREAS, Mr. Chan managed the Davie Tennis Stadium Complex and successfully garnered \$25,000 for improvements, including court resurfacing and new lights; and

WHEREAS, Herb Chan enjoyed serving on the Citywide Elementary Sports Committee for 25 years, coached an OPR men's basketball team for eight years, coached an OPR co-ed softball team for seven years, and was East Bay Chapter President of the Sports Association of Northern California Recreation Agency for the year 2000; and

WHEREAS, Mr. Chan has decided to begin his retirement, enjoy his family and friends even more, and embark upon many new adventures and travels; now, therefore be it
