

### **A RESOLUTION HONORING DAVID LAU FOR 26 YEARS OF EXEMPLARY SERVICE TO OAKLAND PUBLIC WORKS DEPARTMENT AND CONGRATULATING HIM ON HIS RETIREMENT**

**WHEREAS**, Mr. David (Wing Tak) Lau is a dedicated professional engineer who provides personal and inspirational leadership to the members of his team; and

**WHEREAS**, Mr. David Lau began his career with the City of Oakland in 1989 as a Civil Engineer, following five years of practice in the private sector; and

**WHEREAS**, Mr. David Lau was responsible for reviewing and evaluating earthquake damaged buildings throughout Oakland following the Loma Prieta Earthquake of 1989; and

**WHEREAS**, Mr. David Lau was then promoted to the position of Supervising Civil Engineer with the Office of Public Works in 1992; and

**WHEREAS**, Mr. David Lau supervised a team of 12 registered architects and engineers in the construction management of architectural, environmental, street, sewer, slide repair and transportation engineering projects; and

**WHEREAS**, Mr. David Lau established and implemented cost and performance measure standards for the Construction and Field Services Division within the Office of Public Works; and

**WHEREAS**, Mr. David Lau provided training to staff on construction claim analysis, schedule analysis and construction management principles and practices; and

**WHEREAS**, Mr. David Lau was promoted to the position of Principal Civil Engineer, Project Delivery Manager in 1998; and

**WHEREAS**, Mr. David Lau was a key City representative in the statewide benchmarking effort for the past twelve years, bringing solid and globally accepted best practices in the area of planning, engineering, project management, construction management and contract management to the City of Oakland; and

**WHEREAS**, Mr. David Lau developed the City's Green Building Ordinance and successfully lead the design and construction of five LEED Certified building projects following inception of that ordinance; and

**WHEREAS**, Mr. David Lau successfully obtained Caltrans Certification for the City of Oakland's Materials Testing Laboratory; and

**WHEREAS**, Mr. David Lau successfully defended the City of Oakland on numerous multi-million dollar construction claims; and

**WHEREAS**, Mr. David Lau led a renewal of the Public Works Department's Project Management Database, so that the true costs of delivering capital improvement projects could be measured and projects kept on schedule; and

**WHEREAS**, Mr. David Lau has accomplished numerous other things during his many years of truly dedicated service to the City and Citizens of Oakland; now therefore be it
