

### RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF AMY V. DUNNING AS A MEMBER OF THE PUBLIC ETHICS COMMISSION

**WHEREAS**, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, Section 202 of the Oakland City Charter creates the Public Ethics Commission whose purpose is to oversee compliance with various regulations intended to assure fairness, honesty and integrity in government; and

**WHEREAS**, Ordinance No 11961 C.M.S. specifies that members of the Public Ethics Commission are to serve three year terms which are to be staggered so that some appointments will expire every year and appointments to fill a term of office are only to be for the remainder of that term; and

**WHEREAS**, Ordinance No 11961 C.M.S. specifies that the three members of the Public Ethics Commission appointed by the Mayor and confirmed by the City Council will represent local civic organizations with a demonstrated history of involvement in local governance issues;

**WHEREAS**, **Amy V. Dunning** represents a local civic organization, and she has a demonstrated history of involvement in local governance issues; and

**WHEREAS**, the Honorable Mayor Ronald V. Dellums has appointed **Amy V. Dunning** to serve a three-year term on the Public Ethics Commission beginning January 22, 2010 and ending January 21, 2013, filling the seat previously held by **Mario Andrews**, subject to confirmation by the City Council; now therefore be it

**RESOLVED**, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of **Amy V. Dunning** to serve a three-year term on the Public Ethics Commission beginning January 22, 2010 and ending January 21, 2013, filling the seat previously held by **Mario Andrews**.
