A RESOLUTION AUTHORIZING THE REPROGRAMMING OF \$24,615 FROM HOMELESS PROGRAM FUNDS TO: 1) THE ALAMEDA COUNTY- WIDE CONTINUUM OF CARE COUNCIL (\$15,000); 2) THE CITY OF OAKLAND CONTINUUM OF CARE PLAN (\$4,562); AND 3) OPERATION DIGNITY (\$5,053); AND AUTHORIZING A CONTRACT AMENDMENT WITH OPERATION DIGNITY, INC. TO INCREASE THEIR 2002-03 CONTRACT BY \$5,053 FOR A TOTAL AMOUNT OF \$29,986.

INTRODUCED BY COUNCILMEMBER

WHEREAS, the City of Oakland is awarded funding from the U.S. Department of Housing and Urban Development under its Emergency Shelter Grant (ESG) and its Community Development Block Grant (CDBG) Programs; and

WHEREAS, the City of Oakland has allocated General Funds annually for the provision of housing and services through its Emergency Housing Program (EHP) and the Community Promotions Program for Service Organizations (CPPSO); and

WHEREAS, funding was allocated for the above noted programs for the 2001/2002 and 2002/2003 fiscal years and the 2001/2002 fiscal year has ended with \$24,615 in funding remaining in these programs that can be reprogrammed; and

WHEREAS, the Alameda County-wide Continuum of Care Council (ACCOCC) is in need of funds in the amount of \$15,000 to further develop its capacity and to provide support and leadership to service agencies county-wide; and

WHEREAS, Operation Dignity, Inc. (OD) provides shelter and drop-in services to Oakland's homeless and hungry population at the Henry Robinson Multi-Service Center in downtown Oakland and is in need of funds in the amount of \$5,053 for additional winter shelter vouchers in order to house clients during the winter months; and

WHEREAS, the City of Oakland's Continuum of Care Plan (COCP) is an ongoing project that requires funds in the amount of \$4,562 for continuous planning through data collection, research, infrastructure building and human resource development; now, therefore, be it

RESOLVED: That the following balances shall be unencumbered and made available for reprogramming into the 2002-2003 fiscal year under the same funding source for the activities listed below:
