

WHEREAS, the City of Oakland wishes to preserve the livability, social, and economic stability of the City; and

WHEREAS, the City of Oakland has a duty to enforce parking violations as set forth by the Oakland Municipal Code; and

WHEREAS, the City of Oakland collects revenues used to support a multitude of public services from fines resulting from parking violations; and

WHEREAS, the City of Oakland, as well as other municipalities through the State of California are significantly impacted by the current economic recession and revenue reductions from the State of California; and

WHEREAS, the City of Oakland is considering a number of spending reduction proposals and revenue enhancements as a means to eliminate a projected budget deficit for the current fiscal year and beyond; now therefore

BE IT RESOLVED THAT, the City Council of the City of Oakland does ordain as follows:

Oakland Municipal Code Section 10.48.010, **Schedule of Parking Fines**, is hereby amended to add, delete, or modify sections as set forth below (additions are indicated by underscoring and deletions are indicated by ~~strike-through~~ type; portions of the ordinances not cited or not shown in underscoring or strike-through type are not changed).



This Ordinance amends Oakland Municipal Code 10.48.010, Schedule of Parking Fines, to increase the fine amount from \$25.00 to \$30.00 for parking meter violations; from \$25.00 to \$40.00 for one-hour, two-hour and four-hour zones; and from \$32.00 to \$50.00 for red, yellow, white and green zones.
