RESOLUTION NO. 88625 C.M.S.

A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR:

- 1. TO APPLY FOR AND ACCEPT THE CALIFORNIA PRE-KINDERGARTEN SUPPLEMENTAL GRANT IN THE AMOUNT OF THIRTY-TWO THOUSAND FIVE HUNDRED DOLLARS (\$32,500) AND THE CALIFORNIA STATE PRESCHOOL PROGRAM (CSPP) EXPANSION GRANT IN THE AMOUNT OF ONE MILLION TWENTY-ONE THOUSAND ONE HUNDRED SIXTY-SIX DOLLARS (\$1,021,166) FROM THE CALIFORNIA DEPARTMENT OF EDUCATION FOR EARLY CHILDHOOD EDUCATION FROM JULY 1, 2021 THROUGH JUNE 30, 2022; AND**
- 2. TO APPROPRIATE A CONTRIBUTION FROM THE GENERAL PURPOSE FUND IN AN ESTIMATED AMOUNT OF ONE HUNDRED SEVENTY-THREE THOUSAND TWO HUNDRED THIRTY-FOUR DOLLARS (\$173,234); AND**
- 3. TO ACCEPT AND APPROPRIATE ADDITIONAL CSPP GRANT FUNDING THAT BECOMES AVAILABLE FOR THE SAME PURPOSES STATED, DURING THE SAME GRANT TERM, JULY 1, 2021 THROUGH JUNE 30, 2022, AND AMEND THE AGREEMENT WITHOUT RETURNING TO COUNCIL**

WHEREAS, the City of Oakland wishes to apply for and accept a grant in an estimated amount of \$32,500 from the California Department of Education to fund California Pre-Kindergarten Supplemental Program (CPKS) from July 1, 2021 to June 30, 2022; and

WHEREAS, the FY2021-2022 Proposed Budget includes an appropriation of \$32,500 for the CPKS grant in the California Department of Education Fund (2138), HS Classroom and Seasonal Org (78231), Head Start CPKS FY21-22 Project (1005572), and Strengthening Children, Youth & Families Program (YS13); and

WHEREAS, the City of Oakland wishes to apply for and accept a grant in an estimated amount of \$1,021,166 from the California Department of Education to fund California State Preschool Program (CSPP) prekindergarten and family literacy services from July 1, 2021 to June 30, 2022; and

WHEREAS, the FY2021-22 Proposed Budget includes an appropriation of \$1,021,166 for the CSPP grant in the California Department of Education Fund (2138), HS Classroom and Seasonal Org (78231), Head Start CSPP FY21-22 Project (1005571), and Strengthening Children, Youth & Families Program (YS13); and

WHEREAS, due to administrative cost limitations of the contract, a contribution from the General Purpose Fund to cover Central Service Overhead costs estimated at \$173,234 has been included in the FY2021-22 Proposed Budget contingent upon City Council adoption; and

WHEREAS, these grant award funds will be used to provide a prekindergarten and family literacy program at Head Start/CSPP sites in Oakland; and

WHEREAS, the CSPP will provide child development, parenting education and family literacy services to approximately 294 eligible three- and four-year-old children and their families; now therefore, be it,

RESOLVED: That the City Administrator or his designee is hereby authorized to submit an application to the Department of Education, California Pre-Kindergarten Supplemental Program, for the CPKS grant for prekindergarten and family literacy services from July 1, 2021 through June 30, 2022, and to accept said funds in an estimated amount of \$32,500; therefore be it

FURTHER RESOLVED: That the City Administrator or his designee is hereby authorized to submit an application to the Department of Education, California State Preschool Program, for the CSPP grant for prekindergarten and family literacy services from July 1, 2021 through June 30, 2022, and to accept said funds in an estimated amount of \$1,021,166; and be it

FURTHER RESOLVED: That all central services overhead charges associated with these grants in an estimated amount of \$173,234 be offset through a contribution of the General Purpose Fund due to administrative cost limitations; and be it

FURTHER RESOLVED: That should additional grant funds be received from the grantor (California Department of Education) for the same purposes within the existing grant term, the City Administrator or her designee is hereby authorized to accept and appropriate the grant funds without returning to Council within the duration of the grant term July 1, 2021 – June 30, 2022; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator or his designee to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, modifications, payment requests, and related actions which may be necessary to apply for, accept and appropriate the aforementioned grant; and be it

FURTHER RESOLVED: That said grant awards and sub-contract agreements shall be approved as to form and legality by the Office of the City Attorney and placed on file in the Office of the City Clerk.
