

INTRODUCED BY VICE MAYOR DESLEY BROOKS

**Resolution Authorizing Vice Mayor Desley Brooks To Travel To
Beaumont, Texas To Attend The National League of Cities National
Black Caucus Of Local Elected Officials' Annual Summer Conference:
Empowering Our Communities, Strengthening Our Leaders From
August 10-13, 2011**

WHEREAS, Vice Mayor and Council Member Desley Brooks, City of Oakland's delegate to the National League of Cities, wishes to represent the City of Oakland at the National League of Cities Black Caucus Of Local Elected Officials' Annual Summer Conference: Empowering Our Communities, Strengthening Our Leaders which takes place in Beaumont, Texas from August 10-13, 2011; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel cost; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation (including airfare and taxis) is \$550; of registration is \$205; of lodging is \$405; of per diem is \$224 for 4 days; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Vice Mayor and Council Member Desley Brooks seeks Council approval of the fore mentioned estimated costs to travel to Beaumont, Texas, to attend the National League of Cities Black Caucus Of Local Elected Officials' Annual Summer Conference: Empowering Our Communities, Strengthening Our Leaders which takes place in Beaumont, Texas from August 10-13, 2011; now therefore, be it

RESOLVED: that all expenses incurred for said travel are hereby authorized.


