WHEREAS, Plaintiff Sharon Tatmon alleges she was injured when she fell on an uneven City sidewalk in front of 2469 62nd Avenue on September 27, 2010; and

WHEREAS, The City has determined to compromise and settle Plaintiff Sharon Tatmon's claim against it for the sum of Fifteen Thousand Dollars and No Cents (\$15,000.00); now, therefore, be it
