RESOLUTION AUTHORIZING THE CITY MANAGER ON BEHALF OF THE CITY OF OAKLAND, TO ACCEPT ONE HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$125,000) IN DEPARTMENT OF JUSTICE, OFFICE OF COMMUNITY ORIENTED POLICING SERVICES (COPS), "CREATING A CULTURE OF INTEGRITY" GRANT FUNDS AND APPROPRIATE SAID FUNDS TO THE POLICE DEPARTMENT

WHEREAS, the Department of Justice, Office of Community Oriented Policing Services (COPS) has awarded the City \$125,000 in "Creating a Culture of Integrity" grant program funds; and

WHEREAS, the Police Department proposes to use the funds towards the design and implementation of a comprehensive Personnel Information Management Systems (PIMS); and

WHEREAS, the Police Department's task force will access current databases and systems and evaluate the requirements of the new PIMS system; and

WHEREAS, the project evaluation and software development contract costs contained in the project spending plan will incur Capital Projects Assess Fee (CPAF) charges of approximately \$1,688 that are not allowed under the grant's financial guidelines; and

WHEREAS, the Police Department's task force members will make recommendations and develop policy and procedures for the use and implementation of the PIMS system; now, therefore be it

RESOLVED: That the City Council hereby authorizes the City Manager or his designee to accept \$125,000 in grant funds from the Department of Justice, COPS "Creating a Culture of Integrity" grant program and appropriate said funds to Police Department in a federal grant fund and project number to be established and designate that the funds shall be used towards the design and implementation of the PIMS system; and be it

FURTHER RESOLVED: That the Capital Projects Assessment Fee (CPAF) charges of approximately \$1,688 are hereby waived; and be it

FURTHER RESOLVED: That the City Manager or his designee is further authorized to execute all agreements and other documents necessary in connection with the grant.
