Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action for the sum of Seven Thousand Dollars and No Cents (\$7,000.00) payable to Plaintiff Stephen Dunlap and to Oreck & Oreck, his attorney.

This case arises out of a bicycle accident in which Mr. Dunlap lost control of his mountain bike when he went into a pothole on Foothill Blvd. east of High Street on July 11, 2004. This settlement is recommended to avoid a potentially much larger adverse jury verdict. This settlement was approved by the City Council on December 19, 2006.
