

**RESOLUTION AUTHORIZING AMENDMENT NO. 2 TO THE AGREEMENT WITH DON DOMMER ASSOCIATES FOR ADDITIONAL AS-NEEDED ARCHITECTURAL SERVICES FOR AN AMOUNT NOT TO EXCEED \$50,000 FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$100,000**

**WHEREAS**, additional professional services are needed to provide feasibility studies, site evaluations, programming, design, and construction support services for various capital improvements projects that involve facility relocations, building renovation/remodeling, seismic retrofit, and ADA improvements; and

**WHEREAS**, having a pre-selected pool of specialty consultants that can be called upon on an as-needed basis to provide consulting to staff for project design work would expedite the design process and save the City funds; and

**WHEREAS**, Council Resolution No. 75124 C.M.S. awarded an as-needed architectural services contract to **Don Dommer Associates** for a not to exceed amount of \$50,000; and

**WHEREAS**, the City Council finds that the services provided pursuant to the agreement authorized hereunder are of a professional, scientific or technical nature; and

**WHEREAS**, the City Council finds that services under contract will be temporary; and

**WHEREAS**, Council finds that this contract shall not result in the *loss* of employment or salary by any person having permanent status in the competitive service; and

**WHEREAS**, Amendment No. 1 with Don Dommer Associates simply extended the time of performance for the contract and did not add any fundings; now, therefore, be it

**RESOLVED:** That the City Manager is hereby authorized *to* enter into Amendment No. 2 to the Agreement with **Don Dommer Associates** to provide additional architectural services and other design related services to the Project Management Division of the Public Works Agency for an amount *not* to exceed \$50,000, for a total contract amount not to exceed \$100,000; and be it

**FURTHER RESOLVED:** That the City Manager, or his authorized representative, is hereby authorized to approve any subsequent amendments to or extensions of said agreement with the exception of those related to an increase in the total dollar amount of the agreement, provided that such amendments or extensions shall be filed with the City Clerk's Office; and be it

**FURTHER RESOLVED:** That a copy of the agreement will be on file in the City Clerk's Office and will **be** approved for form and legality by the Office of the City Attorney.


