This action arises out of arrests on December 24, 1999. The plaintiffs conted that the officers wrongfully arrested them and used excessive force. The officers deny plaintiffs' allegations. This settlement is recommended as a compromise of this matter and to avoid a potentially adverse jury verdict should the matter be tried.
