RECOMMENDATION

Staff recommends that the City Council adopt a resolution (1) authorizing the City Administrator to close Project C325110, in the Oakland Public Library Trust Fund (7540), and transfer the remaining uncommitted revenue and appropriation of up to \$325,000 to a new project to be used for upgrades and refurbishment of three Oakland Public Library branches: Brookfield, Dimond and Montclair, and (2) to apply for, accept and appropriate additional grants and donations to be used for the same purpose.

REASON FOR SUPPLEMENTAL

As a result of the Life Enrichment Committee (LEC) meeting of October 23, 2012, wherein staff had requested City Council adoption of a resolution:

- Allowing transfer of remaining funds from the 81st Avenue Library;
- Reallocation of the \$325,000 to perform upgrades and refurbishment of the Brookfield, Montclair and Dimond branch Libraries; and
- Authorizing the City Administrator to apply for, accept and appropriate additional grants to be used for the above projects

LEC Chairperson Desley Brooks has requested further information, clarification and inclusion in a supplemental report the following items:

1. A Needs Assessment for the libraries
2. Whether there is an older Capital Improvement Program (CIP) list that prioritizes library projects
3. A list of improvements that have been done on the libraries
4. Whether there is a deadline for raising the 1-1 matching funds
5. Whether these funds can be used for other than capital needs

EXECUTIVE SUMMARY

Attached to this report (ATTACHMENT A) is an Executive Summary of the Needs Assessment that was done for all libraries, including recommendations for new libraries, as part of the 2006 OPL Master Facilities Plan. There is a more detailed and lengthy report available for each library that has previously been made available to City Council in the 2006 *Master Facilities Plan* and that can be produced again.

Attachment B, B-1 and B-2 speak to CIP funding and priorities. Attachment B is a copy of the CIP for FY 2007-09 in the Adopted Policy Budget. Attachments B-1 and B-2, respectively, are 1) a November 27, 2007 Agenda Report to City Council and the Redevelopment Agency regarding the prioritization of projects in several project areas including all of the below libraries; and 2) the approved Resolution attached to the November 27, 2007 report.

The above projects were all designated as capital; however the Eastmont Library project was specifically designated as a relocation feasibility study, which was conducted and concluded that it was not economically feasible.

In response to the question regarding improvements to facilities and how these three libraries were selected, please see Attachment C. The criteria included:

- Whether the facility is older than 1995?
- Whether the facility is leased?
- Whether the facility is/was in a Redevelopment area and received funds?
- Whether the facility has been refurbished, beyond systems, seismic and ADA?

Based on the above criteria, three libraries met the need: Brookfield, Dimond and Montclair. The Library had already identified both Brookfield and Montclair for lower costs refurbishments and had begun some furniture purchases in 2011 for Montclair. New cabling and electrical in Brookfield will begin soon in preparation for a new layout in the library.

In response the question whether the grant funds can be used for other than capital, the Wayne and Gladys Valley Foundation awarded a grant of \$1,000,000 in 2006 for the "construction of a new public library in East Oakland." The Amendment to the 2006 grant award letter approved the change in purpose of grant funds to "upgrades and refurbishment at three additional Oakland

Libraries (Brookfield, Dimond and Montclair).” Consequently, outside of “upgrades and refurbishment,” the funds may not be used for operations, collections, etc.

And finally, in response to the question whether there is a deadline for raising the 1-1 matching funds, a fuller explanation is below, however a concise response is no, there is no deadline.

RECOMMENDATION

Staff recommends that the City Council adopt the resolution included in the October 23, 2012 Life Enrichment Committee packet.

OUTCOME

The outcome is to authorize staff to proceed with the upgrades and refurbishment of the Brookfield, Dimond and Montclair libraries.

BACKGROUND/LEGISLATIVE HISTORY

The Wayne and Gladys Valley Foundation awarded a grant of \$1,000,000 in 2006 for the “construction of a new public library in East Oakland.” The Amendment to the 2006 grant award letter approved the change in purpose of grant funds to “upgrades and refurbishment at three additional Oakland Libraries (Brookfield, Dimond and Montclair).”

ANALYSIS

In order to further address the question regarding a deadline for raising funds:

While most “challenge” or matching grants establish a deadline by which all funds must be raised, the amended grant agreement does not impose this requirement. Instead, the funder specified that:

“The Oakland Public Library must commence the upgrades at the three designated libraries (Brookfield, Dimond and Montclair) within the next twelve months or no later than April 30, 2013.” (Amended grant letter dated April 20, 2012)

The matching grant is not “all or nothing” according to the condition in the amended grant agreement:

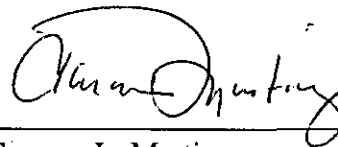
“Each dollar of grant funds must be matched on a 1:1 basis, with an equal amount raised from other private sources (individuals, corporations and foundations).”

To meet this condition, the Library must demonstrate to the Foundation that it raised the qualifying matching funds at the conclusion of the grant. The Library is accountable to the Foundation through reports on fundraising and status of planning and project work that are due every six months. The Library has communicated to the Foundation that the planned project sequence is Montclair Phase I (furniture upgrades; completed in fiscal year 2012), followed by Dimond and Brookfield in fiscal years 2013 and 2014, followed by Montclair Phase II (remainder of furniture upgrades). At the **minimum**, the Library will **complete project plans and schedules for the work at Dimond and Brookfield no later than April 30, 2013 to meet the grantor deadline to commence all projects**. The scheduling of the project work will be based on a number of factors, including impact on the public of any necessary closures of library facilities, availability of City staff to oversee the work, and an assessment of the funds available to carry out the work. Actual expenditures will take place only when funds have been raised to pay for the work.

To date, \$120,000 has been raised toward the fundraising goal of \$325,000. The Library's fundraising plan for these projects involves (1) applying for grants from foundations and institutions with an interest in libraries, youth, literacy, civic engagement and the arts, and (2) local branch fundraising campaigns to engage individuals, local organizations and businesses to contribute the improvement of their local library.

INTRODUCTION

In 2002, on City Council direction, the Oakland Public Library (OPL) embarked on a Master Facilities Plan in response to the community's need for improved services, with the intent to plan for facilities to support these needs. This work builds upon the Library's Strategic Plan as a response to the unmet and growing needs of the community. It is also in response to recent fiscal crises and the community's outcry in support of the Library, which resulted in the Save Oakland Libraries organization and the support and passage in 2002 of Measure Q, the library's dedicated parcel tax.

The Master Facilities Plan articulates a vision that is based on a highly participatory process and includes overall service recommendations and improvements for a revitalized system. The Plan identifies specific improvements to facilities, including capital costs, and implementation strategies for the overall plan, such as funding options and phasing of improvements.

Three rounds of public participation played an important role in the formation of the Master Facilities Plan. A first round of focus groups was held at each of the libraries during the Needs Assessment phase. During the Recommendations phase a second round of community outreach was done through a Speaker's Forum, which included a variety of interested Library Staff, CAC, and project team members going out to over 40 community organizations to present the draft plan's recommendations. Feedback from these as well as Council was then incorporated into the Draft Master Facilities Plan Part 1, presented to Council the Fall of 2004. The second part of the master plan advanced the Main Library development strategy recommendation, as well as refinement of draft recommendations for branches through further coordination with Council offices and City staff. The Main Library recommendation of relocation to the Henry J. Kaiser Center's Arena entailed a full feasibility study and cost development. Project costs were also developed for each of the library improvement projects and potential funding options for the full Master Plan recommendations were reviewed. A third round of community participation was completed through a series of open houses held at each of the library facilities to present the draft Master Plan and Main Library recommendations.

Recommendations:

- ✓ Improve ALL existing branches
- ✓ Add 4 new branches
- ✓ Expand the Main at the Kaiser Arena
- ✓ Seek funding to make it happen

THE NEED

Through the use of a variety of different methods over 4,000 people gave input into the plan. These included community meetings and focus groups held throughout the city, over 1,600 user surveys collected at the Main and all of the branch libraries, and a telephone survey by the City Auditor that reached 1,000 residents, both current library users and non-users alike. The Needs Assessment also mapped existing user patterns to look for underserved areas

and studied technical demographic analysis of both current and future trends in the city to discern future needs. The Library's Community Action Committee, composed of community representatives, and its Youth Leadership Council, composed of youth representatives, were vital in confirming these needs as well as working with the project team to form the vision for the library's future - in services and facilities.

The voices of residents were loud and clear: The Oakland Public Library plays a vital role in meeting residents' needs - in terms of education, enrichment, and technology. The Needs Assessment has identified a lack of space, which constrains the size and diversity of the collection needed for our community. Many of the libraries are too small to accommodate the number of people using them and, at peak use times, library patrons cannot find places to sit. The libraries provide a vital link to technology for Oakland residents: citywide, 25% of the population has no other access to computers, and there is a need for both technology access and training. Patrons see life-skills including literacy and job training, and enrichment programs - such as cultural and literary programs, as vital services for the Library to provide.

THE RECOMMENDATION

The existing libraries play a significant role in the day-to-day lives of Oakland residents and is a well-distributed system. However, many of these facilities are stretched beyond their capacity, and have little if any room to grow to accommodate the many needs of patrons. There are also a few under-served areas of the city without good access to any facility, such as the Laurel/Oak Knoll, and the San Antonio neighborhoods. The vision for the Oakland Public Library system is to improve all the libraries in the system, to supplement the system with new branches in the underserved areas, and to revitalize and expand the Main Library. The Library proposes to do this with three different types of libraries.

⊗ Neighborhood Libraries

The vision for Neighborhood Libraries is to retain and improve the current network of libraries that provide safe, walkable libraries in local neighborhoods. Neighborhood Libraries will be enhanced to address specific service needs of the areas in which they are located. All of the neighborhood facilities will provide core services of materials, seating, and technology access; they will be further tailored to meet the specific needs of the local residents. For example, neighborhoods with a high children's population may have collections focused on children's materials and homework resources (for example, Martin Luther King and Brookfield); and neighborhoods with multi-cultural populations may have collections focused on language materials (for example, Asian, and Chávez). This will allow the Library to keep and improve all existing branch libraries. This will also allow the Library to make more effective use of the limited space in many of these facilities in meeting local needs.

Community Libraries

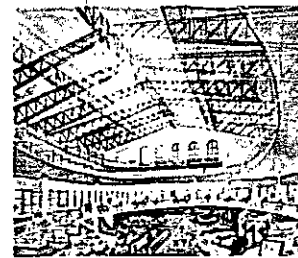
The library will also improve and expand several libraries and add two new libraries to serve as Community Libraries that will provide both core services to their neighborhoods and supplement the Neighborhood Libraries with additional services that residents need, such as computer labs and program rooms. The Community Libraries will allow OPL to effectively and efficiently increase services. Community Libraries will provide a full-array of library services that cannot be offered at the Neighborhood Libraries due to space constraints: augmented materials in increased space; program space, including meeting room(s) for both library and community use; space to accommodate group study, diverse age groups, and recreational use, including areas for children, teens, and adults; and technology training in computer lab settings. These facilities will be geographically distributed throughout the city to ensure accessibility from all neighborhoods, and will be implemented through expansion of existing libraries or new facilities, not consolidation.

Main Library

The Main Library plays a pivotal role in both supporting the system and providing a civic focal point within the city. It also has the opportunity to play a major role in the revitalization of downtown and an improved quality of life for all Oakland residents, including the many new and current downtown residents for whom it is their “branch.” While the vision for the Main Library continues to be formed, the preliminary vision is for a revitalized Main Library as a combination of traditional and new library services in a facility that serves as a physical and metaphorical beacon to all users. Providing “Everything Oakland” – from history, current events, and government to cultural enrichment and education will be a primary civic role of the Main Library. The new Main will also provide a window to the rest of the world, and be an arena that supports the cross-fertilization of ideas and knowledge through programs, interaction, and resources.

The Main Library will provide technical system support for in-depth resources not available at the branches (more extensive collections, fragile historic materials, large scale programs, etc) as well as system-wide support, services including acquisitions, purchasing and processing of materials, technology services, program development resources, and library administration.

The current Main Library facility is about half of the size needed to support these services, and is also burdened by significant infrastructure issues, such as existing data capacity and structural capacity for expansion. In addition, the current building is poorly organized with a large solid core of closed stacks in the middle of the building that makes it very inefficient to operate both these closed spaces and the public spaces that surround it. Of the options examined for the Main Library, including renovation and expansion of the existing Main Library facility or relocation to another facility, the relocation of the Main Library to the Henry Kaiser Center’s Arena is the preferred development strategy. This location presents a number of opportunities, including a more

public and civic location, with the capacity to house the needed space, as well as the opportunity to preserve the historic landmark and give a new life to the Kaiser Center and keep it from being closed for an extended period of time. The full study of the development options for the Main Library are outlined in the *Feasibility Study of the Adaptive Reuse of the Kaiser Arena as a New Main Library* report being issued along with this report.

There are also citywide services that are based out of other library facilities, such as special collections (Asian's and Chávez's language collections, African-American Museum and Library of Oakland, or AAMLO, etc.) as well as special services, including literacy. Many of these services will remain at their current locations to serve their local constituency while continuing to serve the city as a whole as well.

A new service model that emphasizes customer service and more efficient delivery systems of both materials and services will be implemented in all facilities (utilizing partnerships, self-service and use of technology such as self-check out machines, radio frequency identification, etc.). Such service models will free up library staff from more repetitive tasks enabling them to assist patrons with value-added services such as information and referral and increased programming.

IMPLEMENTATION

Capital costs, including comprehensive project budgets for all recommended library improvements were developed. Funding options, including local funding measures and grant funding opportunities are considered. The Plan also developed draft phasing criteria to guide the implementation of projects in a way that allows it to move steadily towards its goal of full implementation of its vision for improved library services and facilities while being fiscally responsible to the residents of Oakland.

City Resolution Accepting and Appropriating a Contribution of Redevelopment Agency Funds under the Cooperation Agreement in an Amount not to Exceed \$5,064,910 for Certain Public Facility and Park Projects in the Central District, Coliseum, Central City East, and West Oakland Redevelopment Project Areas for FY 2007-09

SUMMARY

Staff requests approval to allocate Redevelopment Agency funding for certain public facility and park projects in the Central District, Central City East, Coliseum, and West Oakland Redevelopment Project Areas for FY 2007-09. The Office of Parks and Recreation (OPR), with the assistance of Community and Economic Development Agency (CEDA) Project Delivery staff and the City Administrator's Office, prioritized and allocated funding to eligible park projects within the four Project Areas. The Oakland Public Library (OPL) similarly prioritized and allocated funding to eligible library projects. All of the park projects were chosen from the Capital Improvement Program - Unfunded Requests list while the library projects were from OPL's FY 2007-09 Capital Improvement Projects list.

Staff has prepared two resolutions. The first resolution authorizes the Redevelopment Agency to contribute Central District, Central City East, Coliseum, and West Oakland Project Areas funds to the City under the Cooperation Agreement. The second resolution authorizes the City to accept and appropriate Agency funding for various improvement projects in the Project Areas.

FISCAL IMPACT

The Agency will allocate \$5,064,910 in total for all four Project Areas. Proposed spending is as follows:

Central City East Tax Allocation Bond Series 2006A-TE Fund (9542), Central City East Organization (88699), Central City East Facilities/Infrastructure Project (S233389) - \$100,000, Central City East Project (S233310) - \$474,000

Central City East Operations Fund (9540), Central City East Organization (88699), Central City East Land Assembly and Relocation Project (S233350) - \$60,000, Central City East Project (S233310) - \$6,000,

West Oakland:

West Oakland Operations Fund (9590), West Oakland Base Reuse Organization (88679), West Oakland Project (S233510) - \$1,574,910

These Redevelopment Agency funds will be utilized to reimburse the City's Oakland Redevelopment Agency Projects Fund (7780), Engineer Design – Project Management Organization (92270), De La Cruz ORA Project (C329510), Chavez ORA Project (C329410), 81st Avenue Library Project (C274420), and City Projects to be established for Malonga Casquelourd Art Center, Jefferson Square Park, Chinese Garden Park, Sobrante Park, Officer Willie Wilkins Park, Raimondi Park, Brookfield Library, Martin Luther King Jr, Library, Eastmont Library, Elmhurst Library, and Melrose Library

Operations and maintenance cost increases for most of the projects are estimated to remain within existing service level funding. The Josie De La Cruz and Eastmont Library projects will not immediately affect current service level funding since they are planning projects. Construction of the 81st Avenue Library will result in additional staffing and operating costs, but those costs are anticipated to be covered by the Measure Q Library Parcel Tax.

The improvement of Raimondi Park is expected to result in higher operations and maintenance costs due to increased use of the park. Existing staff would be re-assigned to provide services for the new capital improvements, which could reduce service levels at other existing facilities and parks. However, the new artificial turf field to be installed in Raimondi Park is estimated to reduce mowing and general maintenance costs by about \$6,000 per year with additional savings on fertilizer, water, and re-seeding/re-sodding, which artificial turf does not require.

The artificial turf field is anticipated to last for at least a decade. At the end of that time, the replacement cost for the artificial turf would be approximately \$1 million. Re-seeding one of Raimondi Park's natural turf fields, along with associated operations, costs about \$200,000. To remain playable, the heavily utilized fields at Raimondi Park require re-seeding as frequently as every two years, a level of maintenance the City has been unable to provide.

Hard costs, such as electricity for the sports lighting, have not been quantified, but it may be possible to recoup these costs through higher rental rates for night games.

Detailed descriptions of the 17 projects above are provided in Attachment A.

BACKGROUND

For public facility and park projects, the Agency budgeted in its FY 2007-09 Adopted Budget \$2,000,000 for the Central District, \$2,250,000 for the Coliseum Area, and \$1,000,000 for Central City East. During the budget process, Lincoln Square Park in the Central District, and Josie De La Cruz Park and Cesar Chavez Park in Central City East were identified as public facility and park projects and allocated funding. In separate actions following the adoption of the Agency budget, Council approved and allocated funding out of the budgeted funds for the Madison Square Park and Rainbow Teen Center projects in the Central District and Coliseum Area respectively. OPR, working with CEDA Project Delivery staff and the City Administrator's Office, has since identified seven additional public facility and park projects to receive allocations.

Staff chose the projects from the Capital Improvement Program - Unfunded Requests list and gave preference to projects which were also on the Parks Prioritization List. Established in July 2007, the Prioritization List serves as a guiding plan for responding to funding opportunities and implementing Oakland's parks and open space capital improvements. Given the limited funds available, staff decided to fund those projects which could be advanced in discrete phases and would result in functional improvements with only partial funding.

Concomitant to staff's selection of park projects is the West Oakland Project Area Committee's (WOPAC) support of Raimondi Park. The WOPAC, which advises the City Council on expenditures of West Oakland Redevelopment Project Area tax increments, voted on March 14, 2007 to recommend funding the Raimondi Park project with \$336,107. Then on September 19, 2007, the WOPAC voted to add another \$1,238,803 to the Raimondi Park project for a total of \$1,574,910 in recommended funding. This amount will complete Phase One of a three phased

plan developed by the Friends of Oakland Parks and Recreation with input from the community and City staff.

The amounts the Agency budgeted for public facilities and parks in the Coliseum and Central City East Project Areas were intended to support libraries as well as parks. OPL requested Agency support for six libraries in the Coliseum and Central City East Project Areas in the FY 2007-12 Proposed Capital Improvement Program. Only two libraries, the Brookfield and Martin Luther King, Jr. Branch Libraries in the Coliseum Area, were included in the FY 2007-12 Adopted Capital Improvement Program (CIP). The other four libraries were left unfunded. In October 2007, OPL submitted to the Agency a statement of funding need for the 81st Avenue Branch Library in the Coliseum Area. Coliseum School Set Aside funds will be used to meet that need.

During the budget process, \$900,000 of the \$1,000,000 budgeted for Central City East's public facilities and parks was allocated to two parks (Josie De La Cruz and Cesar Chavez). OPR, the City Administrator's office, and CEDA Project Delivery allocated the remaining \$100,000 to the same two parks when prioritizing projects for Agency funding. To provide for the three library projects in Central City East, several line items in the Central City East FY 2007-09 budget will be reapportioned.

The Central City East Project Area Committee (CCEPAC), which advises the City Council on expenditures of Central City East Redevelopment Project Area tax increments, had voiced its support for Central City East libraries in previous CCEPAC meetings, but had not recommended a specific funding amount. The proposed spending for the Eastmont, Elmhurst, and Melrose Libraries will be presented to the CCEPAC for its consideration on December 3, 2007.

KEY ISSUES AND IMPACTS

The proposed public facility and park projects are eligible for Agency funding under redevelopment law, which requires that improvements to public recreation areas, parks, and open space serve a redevelopment purpose. A redevelopment agency may with the consent of the city fund installation and construction of publicly-owned buildings and facilities, but only if the city can make the following findings: (1) that the improvements are of benefit to the redevelopment project area or the immediate neighborhood in which the project is located; (2) that no other reasonable means of financing the improvements are available to the city other than redevelopment funding; (3) that the improvements will assist in the elimination of one or more blight conditions in the project area; and (4) that the improvements are consistent with the five-year implementation plan for the project area.

Redevelopment law prohibits the use of redevelopment funds to pay for normal maintenance or operations of publicly owned facilities. Blight conditions recognized by redevelopment law include, among other things, unsafe or unhealthy buildings, serious building code violations, serious dilapidation and deterioration caused by long-term neglect, construction that is vulnerable to serious damage from seismic or geologic hazards, faulty or inadequate water or sewer utilities, conditions that prevent or substantially hinder the viable use or capacity of

buildings, or buildings of substandard, defective, or obsolete design or construction given current development standards. The attachment to this report explains how each of the improvements will address blight conditions in the Project Areas.

No other reasonable means of financing these projects are available to the City other than Agency funding. The FY 2007-12 CIP, which addresses the City's major capital needs for the five-year period through June 30, 2012, identifies new capital projects and sources of funding. City sources can fund \$134.6 million in projects. The largest source of funding comes from Measure B (\$69.3 million for street improvements) followed by sewer service fee revenues (\$45.3 million for sewer maintenance projects). City sources available for FY 2007-12 CIP projects such as public facilities and parks include the Capital Improvement Reserve, the Joint Powers Financing Authority (JPFA) Capital Project 2005 fund, and the Municipal Capital Improvement – 1989 Local Government Fiscal Autonomy (LGFA) Refunding. These funds can support a total of \$19 million in projects. Unfunded CIP projects, which have no identified revenue source and include the proposed public facility and park projects, total an estimated \$54.4 million.

PROGRAM DESCRIPTION

The principal objectives of the Redevelopment Plans for the Central District, Coliseum, Central City East, and West Oakland Project Areas include the abatement of physical and economic blight through the redevelopment of vacant and underutilized properties, and the replacement of obsolete infrastructure. The Plans provide the Agency with powers, duties and obligations to implement and further the program generally formulated in the Plans for the redevelopment, rehabilitation and revitalization of the area within the boundaries of the Project Areas.

SUSTAINABLE OPPORTUNITIES

Economic: The projects will generate jobs for Oakland residents as well as business and sales tax and other revenues for the City by those contractors and suppliers who work on the project. They will also improve the physical environment of Project Area neighborhoods, making those neighborhoods more attractive to residents and to businesses that can provide employment within Oakland.

Environmental: Wherever possible, the projects will be designed to conserve resources, minimize maintenance, incorporate sustainable design elements, and utilize recycled-content materials.

Social Equity: The public facility and park projects will upgrade community and City amenities and improve services for underserved neighborhoods. They will also provide a stimulus to these neighborhoods, which have lacked new construction for an extended period.

DISABILITY AND SENIOR CITIZEN ACCESS

The projects will maintain accessibility to persons with disabilities and senior citizens. All construction will meet the requirements of the Americans with Disabilities Act.

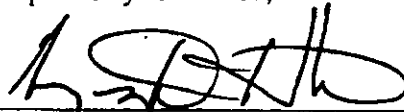
RECOMMENDATION AND RATIONALE

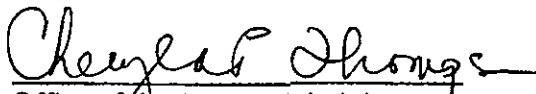

Priority Public Facility and Park Projects for Redevelopment Agency Funds
Fiscal Year 2007-09

PROPOSED PUBLIC PROJECTS

PARKS AND RECREATION CENTERS

CENTRAL DISTRICT.

Lincoln Square Park

Location: 261 11th Street.

Project Description: Demolish existing asphalt play yard. Provide new synthetic turf field connecting between Lincoln Square and the Lincoln Elementary School.

Project Benefits and Blight Elimination: The park is located next to Lincoln Elementary School, where enrollment exceeds capacity. The school relies on Lincoln Square Park for additional recreational space and children wait in line to play. Four daycare centers and two Head Start Programs also use the park. This project will make better use of the space between Lincoln Square and Lincoln Elementary school and support the goal of the Central District Redevelopment Project Area to improve and expand services for an underserved neighborhood. Therefore the improvements will assist in the elimination of the following blight condition: obsolete design which hinders the viable use and capacity of the park.

Monetary Contribution: \$500,000 approved for FY 2007-08.

Funding Source: 9533 Central District Tax Allocation Bond Series 2005.

Madison Square Park

Location: 810 Jackson Street.

Project Description: Grade and install new paving surfaces, a retaining wall, youth play court, basketball court, new trees and a landscaped area.

Project Benefits and Blight Elimination: This project will provide a gathering space for community groups who have been using the nearby BART plaza site for various cultural and fitness activities. Due to the planned demolition of the vacant BART Administration Building located at the Lake Merritt BART Plaza, the plaza will be closed, displacing hundreds of community members. There is an urgent need to provide the community groups with a space where they can continue their activities. In addition to making a space for the existing groups, the improvements will provide additional recreational amenities to local residents and youths currently limited to the over-crowded Lincoln Square Recreational Center.

Therefore the improvements will assist in the elimination of the following blight condition: substandard design which hinders the viable use and capacity of Madison Square Park.

Monetary Contribution: \$150,000 approved for FY 2007-08.

Funding Source: 9533 Central District Tax Allocation Bond Series 2005.

Malonga Casquelourd Center for the Arts

Location: 1428 Alice Street.

Project Description: Overhaul all three building elevators, radiators in all performance spaces, HVAC system and boilers. Replace carpet throughout the building. Add emergency exit lighting and upgrade lighting throughout the building. Install new fixtures in the public bathrooms.

Project Benefits and Blight Elimination: Malonga is a heavily used, year round facility operated on a 24/7 basis. These improvements address mechanical, electrical, structural, HVAC, and mold issues which jeopardize the safety and health of persons living and working in the building. Renovating Malonga will assist in the elimination of the following blight conditions: an unsafe and unhealthy building, code violations, and serious dilapidation which hinder the viable use of the building.

Monetary Contribution: \$550,000 proposed for FY 2007-08.

Funding Source: 9533 Central District Tax Allocation Bond Series 2005.

Jefferson Square Park

Location: 618 Jefferson Street

Project Description: Demolish existing storage building. Provide new rubber safety surface, new play structure and fence for tot lot. Trim back existing trees at tot lot. Add a new dog park in existing asphalt and sand area with new fencing and gates.

Project Benefits and Blight Elimination: The removal of the storage building will make the park more visible, reduce the collection of trash and debris in the area, and improve park security. Tot lot upgrades and tree trimming will also assist with visibility and security issues. The new dog park will help deter the illicit uses that have been occurring in the park by encouraging residents from the neighboring communities to use the park. These improvements will assist in the elimination of the following blight conditions: physical conditions which are a magnet for dumping and other blighting activities which also pose a threat to public safety and welfare.

Monetary Contribution: \$557,000 proposed for FY 2007-08.

Funding Source: 9533 Central District Tax Allocation Bond Series 2005.

Chinese Garden Park

Location: 7th and Harrison Streets

Project Description: Make entry improvements including pathway, seat walls, tree planting and irrigation. Repair and make safety improvements to existing pathway through the garden.

Project Benefits and Blight Elimination: The poor condition of the seat walls and pathway is a blemish on the community and a safety hazard. Aesthetic enhancement of the park, which serves local businesses as well as residential users, would encourage more commercial activity in the neighborhood and generate more sales tax revenue for the City of Oakland. Therefore the improvements will assist in the elimination of the following blight conditions: visual blight which impairs investment in the surrounding neighborhood, obsolete design, and code violations.

Monetary Contribution: \$243,000 proposed for FY 2007-08.

Funding Source: 9533 Central District Tax Allocation Bond Series 2005.

COLISEUM**Rainbow Teen Center**

Location: 5818 International Boulevard

Project Description: Acquisition funds to purchase an existing building for a new Teen Center.

Project Benefits and Blight Elimination: The vacant building will be renovated and put to new use as a Teen Center, increasing the adjacent Rainbow Recreation Center's capacity to serve the community. The additional activity from neighborhood youth will enliven the street and assist in revitalizing the neighborhood. Therefore the purchase and future renovation of this building will assist in the elimination of the following blight conditions: visual blight caused by an empty and poorly maintained building, code violations, and a high number of vacancies along International Boulevard.

Monetary Contribution: \$800,207 approved for FY 2007-08.

Funding Source: 9455 Coliseum Tax Allocation Bond Series 2006B-TE Fund.

Sobrante Park

Location: 470 El Paseo Drive.

Project Description: Provide and install a new restroom structure and new utility connections to street service point. Provide handicap accessible pathways to the park's ball field, tot lot, and restrooms.

Project Benefits and Blight Elimination: At 4.69 acres in size, Sobrante Park requires a field restroom to provide for the health and comfort of park users. The

new restroom will help contain sanitary functions to an appropriate place and maintain the cleanliness of park areas. The new pathways are necessary to make the park fully accessible. Therefore the improvements will assist in the elimination of the following blight conditions: obsolete design, inadequate facilities creating health and safety violations, and impaired property values due to the lack of sanitary facilities.

Monetary Contribution: \$288,630 proposed for FY 2008-09.

Funding Source: 9455 Coliseum Tax Allocation Bond Series 2006B-TE Fund.

Officer Willie Wilkins (Elmhurst) Park Tot Lot

Location: 1800 98th Avenue.

Project Description: Remove existing play equipment and install new equipment for children ages 2-5 with rubberized safety surfaces.

Project Benefits and Blight Elimination: The improvements will replace obsolete equipment with more functional and safer play structures. These improvements will assist with the elimination of the following blight conditions: obsolete and substandard facilities that are unsafe.

Monetary Contribution: \$211,370 proposed for FY 2008-09.

Funding Source: 9455 Coliseum Tax Allocation Bond Series 2006B-TE Fund.

CENTRAL CITY EAST

Cesar Chavez Park

Location: Foothill Boulevard between Bridge and 38th Avenues.

Project Description: Repave existing basketball court. Provide limited accessible asphalt concrete pathway. Replace tot lot surfacing and replace limited play equipment.

Project Benefits and Blight Elimination: Repaving the basketball court and resurfacing the tot lot will reduce tripping hazards and provide safer surfaces for play. Replacement of some of the play equipment is necessary to meet safety standards. Therefore the improvements will assist in the elimination of the following blight conditions: code violations, obsolete design, serious dilapidation and deterioration caused by long-term neglect, and unsafe conditions which hinder the viable use of the park.

Monetary Contribution: \$200,000 approved for FY 2007-08.

\$50,000 additional proposed for FY 2007-08.

Funding Source: 9542 Central City East Tax Allocation Bond Series 2006A-TE Fund.

Josie de la Cruz Park

Location: 1637 Fruitvale Avenue.

Project Description: Develop a conceptual park improvement plan through community process and implement selected elements that are within the project budget.

Project Benefits and Blight Elimination: Potential improvements will address accessibility issues and adequate lighting for safety, as well as the provision of synthetic turf for safe play surfaces, gathering spaces that invite community use and deter illegal activities, and amenities that encourage recreational use and other healthful activity. Therefore the improvements will assist in the elimination of the following blight conditions: code violations, obsolete design which contributes to illegal activities, results in public safety and welfare problems, and hinders the viable use and capacity of the park.

Monetary Contribution: \$700,000 approved for FY 2007-08.

\$50,000 additional proposed for FY 2007-08.

Funding Source: 9542 Central City East Tax Allocation Bond Series 2006A-TE Fund.

WEST OAKLAND

Raimondi Park Fields

Location: 1800 Wood Street.

Project Description: Renovate and improve existing park with a new baseball diamond, a new synthetic turf multi-purpose field, and field lighting. Upgrade infrastructure with limited curb ramp and sidewalk repair, and minor paving repairs for handicap access.

Project Benefits and Blight Elimination: This park is one of the most heavily used in the City, but it is seriously dilapidated. The renovation will make the park safer to use and more easily accessible and assist in the elimination of the following blight conditions: serious dilapidation and deterioration, code violations, obsolete and substandard facilities.

Monetary Contribution: \$1,574,910 proposed for FY 2007-08.

Funding Source: 9590 West Oakland Operations Fund.

LIBRARIES

COLISEUM

Brookfield Branch Library

Location: 9255 Edes Avenue.

Project Description: Supplement Council District 7 PayGo funding to replace glazing on the sides and roof of the building with insulating opaque embossed metal plates. Study potential accessibility upgrades.

Project Benefits and Blight Elimination: The insulating plates will reduce excessive heat gain through the existing skylight in the children's area and increase the viable use of the building. The improvement will assist in the elimination of the following blight condition: defective design which substantially hinders the viable use and capacity of the library.

Monetary Contribution: \$150,000 proposed for FY 2007-08.

Funding Source: 9455 Coliseum Area Tax Allocation Bond Series 2006B-TE.

Martin Luther King, Jr. Branch Library

Location: 6833 International Boulevard.

Project Description: Create new children's and teen's areas, upgrade technology, and install new gates for the parking lot.

Project Benefits and Blight Elimination: Dedicated areas for children and teens will serve the high number of youth in the neighborhood. Technology upgrades are necessary to increase computer access. New gates will prevent trash dumping in the library's parking lot. The improvements will assist in the elimination of the following blight conditions: code violations and obsolete design which hinders the viable use and capacity of the library.

Monetary Contribution: \$350,000 proposed for FY 2007-08.

Funding Source: 9455 Coliseum Area Tax Allocation Bond Series 2006B-TE.
9450 Coliseum Operations Fund.

81st Avenue Branch Library

Location: 81st Avenue and Rudsdale Street.

Project Description: The Oakland Public Library is building a new 21,000 square foot public library as part of a joint project, which will include two new schools by the Oakland Unified School District. In 2004, the Oakland Library received a \$6.5 million state grant and a \$3.5 million local match (in Coliseum School Set-Aside funds) to build the new library. Due to the increase in the cost of construction materials since 2004, the 81st Avenue Library construction project has a shortfall of approximately \$3.0 million. The \$500,000 request from the Coliseum School Set-Aside augments the local \$3.5 million match and aids the Oakland Public Library in raising funds from other public and private donors to meet this shortfall.

Project Benefits and Blight Elimination: The new library is a much needed facility for the community with more than 36,000 persons living within a one-mile radius and over 38% of that population under the age of 19. The state-of-the-

art building, designed to be visually appealing, will help beautify the neighborhood and help stimulate revitalization of an area which has experienced little new construction. By providing a center for safe and positive activities, the library will also help promote public safety in the high crime area. Therefore the construction of the library will assist in the elimination of the following blight conditions: visual blight, stagnant property values, and a high crime rate which constitutes a serious threat to the public welfare.

Monetary Contribution: \$500,000 proposed for FY 2008-09.

Funding Source: 9527 Coliseum School Set-Aside.

CENTRAL CITY EAST

Eastmont Branch Library

Location: 7200 Bancroft Avenue.

Project Description: Conduct a feasibility study to examine the extent to which improvements should be made at the current site and the practicality of changing the library's location.

Project Benefits and Blight Elimination: The study examines issues arising from the current location of the library in the Eastmont Town Center, such as visibility, perception, and differentiation from the social services agencies housed within the closed mall. The study will assist in the elimination of the following blight conditions: substandard and obsolete design which hinders the viable use and capacity of the library, and incompatible land uses,

Monetary Contribution: \$60,000 proposed for FY 2007-08.

Funding Source: 9542 Central City East Tax Allocation Bond Series 2006A-TE.

Elmhurst Branch Library

Location: 1427 88th Avenue.

Project Description: Supplements Council District 7 PayGo funding to add a new unisex ADA-compliant restroom and a new high-low drinking fountain within the existing library, paint the building exterior, and develop potential makeover.

Project Benefits and Blight Elimination: The drinking fountain and public restroom ensure the comfort and health of all patrons, while the exterior paint improves the appearance of the library and makes it more visible to the public. Therefore the improvements will assist in the elimination of the following blight conditions: deterioration and obsolete design given current development standards.

Monetary Contribution: \$100,000 proposed for FY 2007-08.

Funding Source: 9542 Central City East Tax Allocation Bond Series 2006A-TE.

Melrose Branch Library

Location: 4805 Foothill Boulevard.

Project Description: Replace and repair rotted wood windows and frames on main floor and lower level, and make electrical improvements.

Project Benefits and Blight Elimination: The serious dilapidation and deterioration of the window frames in this historic building present building code violations and require them to be replaced. Water seeps through the frames and many of the windows can no longer be opened. The insufficient electrical capacity on the lower level also needs to be corrected to bring the building up to code. Therefore the improvements will assist in the elimination of the following blight conditions: building code violations, an unsafe and unhealthy building, obsolete construction.

Monetary Contribution: \$380,000 proposed for FY 2007-08.

Funding Source: 9542 Central City East Tax Allocation Bond Series 2006A-TE.

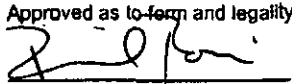
