## RESOLUTION AUTHORIZING THE AMENDMENT OF THE REPAYMENT AGREEMENT WITH THE OAKLAND REDEVELOPMENT AGENCY FOR THE STANFORD-ADELINE REDEVELOPMENT PROJECT

WHEREAS, Health and Safety Code Sections 33128, 33205, 33206, and 33220 authorize a community to contract with a redevelopment agency for the furnishing of staff services and the provision of other assistance to the agency, and Health and Safety Code Section 33610 authorizes a community to appropriate funds as a loan or grant to a redevelopment agency for the administrative, overhead, and planning expenses of the agency; and

WHEREAS, to assure successful redevelopment for the Stanford-Adeline Redevelopment Project Area, the Redevelopment Agency entered into a repayment agreement with the City of Oakland on June 25, 2002 to provide services to the aforesaid project; and

WHEREAS, the additional amounts need to fund project-related costs for FY 2003-05 in connection with the Stanford-Adeline Redevelopment Project are estimated to be:

WHEREAS, the Agency intends to reimburse the City for the above-mentioned activities from tax increment funds collected from the County of Alameda from the Stanford-Adeline Redevelopment Project Area; now, therefore, be it

RESOLVED: That the City Manager is hereby authorized and empowered to negotiate and enter into an appropriate repayment agreement with the Oakland Redevelopment Agency for the Stanford-Adeline Project in the amount of \$133,016 for Fiscal Years 2003-05, for the activities stated above; and be it

FURTHER RESOLVED: That the amendment to the repayment agreement be reviewed and approved by the City Attorney prior to execution, and a copy be placed on file with the City Clerk.
