**WHEREAS:** Plaintiff Shenell Steward-Jacks has filed the above-captioned lawsuit alleging that a dangerous condition of City of Oakland property, to wit an uneven portion of a city sidewalk located at 1324 Adeline Street, Oakland, California caused her to trip and fall; and

**WHEREAS:** Plaintiff Shenell Steward-Jacks alleges that she sustained injury and damages caused by the trip and fall; and

**WHEREAS:** the City of Oakland, without admitting guilt, wrongdoing or liability of any sort whatsoever, believes that it is in the best interest of the City of Oakland to terminate the above-captioned lawsuit through settlement.

**THEREFORE BE IT RESOLVED:** that the City Attorney is authorized and directed to compromise and settle the case of Shenell Steward-Jacks v. City of Oakland, et al., City Attorney's File No. 26083, for a sum not to exceed Eleven Thousand Dollars and No Cents (\$11,000.00) made payable to Plaintiff Shenell Steward-Jacks and Terry D. Buller, Esq., her attorney.
