



## RESOLUTION AUTHORIZING COUNCILMEMBER DESLEY BROOKS TO TRAVEL TO WASHINGTON D.C. TO ATTEND THE 2017 LEAGUE OF CITIES CONGRESSIONAL CITY CONFERENCE FROM MARCH 10-15, 2017

WHEREAS, Councilmember Desley Brooks, the City of Oakland's District 6 representative, will represent the City of Oakland at the 2017 League of California Cities Congressional City Conference from March 10-15, 2017; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$500.00 (air) and up to \$120.00 (ground); lodging is \$1600.00 per diem is \$300.00; and conference registration fee is \$900.00; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Councilmember Brooks seeks Council approval of the aforementioned estimated costs to travel to Washington D.C. to attend the 2017 League of California Cities Congressional City Conference, March 10-15, 2017; now, therefore, be it


RESOLVED: That all expenses incurred for said travel are hereby authorized.
