INTRODUCED BY COUNCILMEMBER GALLO

RESOLUTION AUTHORIZING TRAVEL AND TRAVEL EXPENSES FOR COUNCILMEMBER NOEL GALLO TO TRAVEL TO MEXICO ON A TRADE MISSION WITH THE CENTER FOR INTERNATIONAL TRADE DEVELOPMENT IN SACRAMENTO AND THE HISPANIC CHAMBERS OF COMMERCE IN SACRAMENTO, ALAMEDA COUNTY, AND SAN JOSE FEBRUARY 12-15, 2014

WHEREAS, Councilmember Gallo seeks Council approval to travel to Mexico on a trade mission with the Center for International Trade Development in Sacramento and the Hispanic Chambers of Commerce in Sacramento Alameda County, and San Jose from February 12-15, 2014, and approval of travel expenses for the trip estimated to be \$500 for airfare, \$500 for lodging for 3 nights and \$168 for per diem expenses for 3 days, and

WHEREAS, pursuant to City Council Resolution No 82800 C M S approved on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs, and

WHEREAS, in compliance with City Council Resolution No 82800 C M S . the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds, now, therefore, be it

RESOLVED: That the Council authorizes Councilmember Gallo to travel to Mexico on a trade mission with the Center for International Trade Development in Sacramento and the Hispanic Chambers of Commerce in Sacramento, Alameda County, and San Jose from February 12-15, 2014, and authorizes payment of travel expenses estimated to be \$500 for airfare, \$500 for lodging for 3 nights and \$168 for per diem expenses for 3 days
