Pursuant to Section 401 of the Charter, the City Attorney recommends settlement of the above-entitled matter arising out of an incident on March 1, 2000 wherein it is alleged that officers of the Oakland Police Department used excessive force against the plaintiff.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended in the total amount of One-Hundred Ten Thousand Dollars (\$110,000) to be paid by the City of Oakland. The proposed settlement is to be made payable to John Davis and John Burris, Esq., his attorney.
