RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE CONTRACTS WITH BAY AREA COMMUNITY SERVICES, V. I. P. TRANSPORTATION DBA AS AT YOUR SERVICE (AYS) V.I.P.; FRIENDLY TRANSPORTATION DBA AS FRIENDLY CAB COMPANY, GREYLINE CAB COMPANY, METRO YELLOW CAB COMPANY, YELLOW CAB COMPANY; AND VETERANS TRANSPORTATION, INC. DBA AS VETERANS CAB COMPANY TO PROVIDE PARATRANSIT SERVICES FOR FISCAL YEAR 2004-2005 IN AN AMOUNT NOT TO EXCEED \$950,000 AND TO EXECUTE ANY AMENDMENTS TO THE CONTRACTS FOR ANY ADDITIONAL AMOUNTS RECEIVED UNDER THE GRANT WITHOUT RETURNING TO THE CITY COUNCIL

**WHEREAS**, THE City of Oakland claims Measure B funds allocated for Oakland and Piedmont residents to provide paratransit services; and

WHEREAS, City of Oakland General Fund resources are available and were appropriated in the FY 2003-2005 Budget for continued delivery of this service; and

WHEREAS, the City of Oakland contracts on a non-exclusive basis, with taxis and van companies to provide paratransit services for the elderly and disabled; and

**WHEREAS**, the City of Oakland supports the pilot senior shuttle service in West Oakland provided by Bay Area Community Services; and

WHEREAS, the City desires to maintain this service without disruption; and

**WHEREAS**, the City Council finds these contracts will not result in the loss of employment or salary by any person having permanent status in the competitive civil service; and

WHEREAS, the City lacks the fleet, the van equipment and the support structure to operate this service with City employees and has never provided or operated such a service; and

WHEREAS, the City Council finds that following the bidding procedures specified in the Purchasing Ordinance is not in the best interests of the City because the City enters into contract with all taxi companies and van companies that are licensed to do business in the City and meets the City's requirements, and the City is requesting

authorization to enter into non-exclusive contracts with every applicant to provide paratransit services; and

WHEREAS, all of the companies for which contracting authorization is being requested, meet the City's requirements for paratransit services; and

**WHEREAS**, the City wishes to enter into agreements with the following paratransit providers for the amounts not to exceed as specified below:
