#### **SUMMARY**

On May 18, 2004, pursuant to Chapter 8.28, of the Oakland Municipal Code, an administrative hearing was held to hear protests and resolve any inconsistencies or inequities prior to the public hearing before the City Council. Each affected property owner was notified of the administrative hearing. Accordingly, seven cases were resolved and removed from the list of delinquent properties. A resolution has been prepared confirming the placement of liens on 5,929 accounts and authorizing the subsequent assessment for all fees and charges, should they remain unpaid at the time of submission to the County Assessor.

#### FISCAL IMPACT

Waste Management of Alameda County has billed the City \$697,628.69 which represents monthly charges for October through December 2003 and quarterly charges for January through March 2004. The bill becomes payable after the public hearing is held. Property owners owe the City delinquent garbage charges and administrative fees totaling \$999,202.76 for this period. The City will transfer these charges to the Alameda County Tax Rolls to avoid a \$697,628.69 charge to the General Fund.

#### **BACKGROUND**

The public hearing represents monthly billings for October through December 2003 and quarterly billings for January through March 2004.
