INTRODUCED BY COUNCILMEMBER NOEL GALLO

### RESOLUTION RE-APPOINTING JAN WASHBURN AS THE CITY OF OAKLAND'S TRUSTEE TO THE ALAMEDA COUNTY MOSQUITO ABATEMENT DISTRICT BOARD

**WHEREAS**, the Alameda County Mosquito Abatement District was formed in 1930 pursuant to the Mosquito Abatement Districts Act authorizing formation of mosquito control districts in the State of California; and

**WHEREAS**, the California Health and Safety Code governs the creation of mosquito abatement districts; and Sections 2021 and 2024 of the California Health and Safety Code stipulate that a city council member may appoint one person as a trustee to its district for a two or four-year term, respectively; and

**WHEREAS**, Dr. Washburn's term as the City's appointed trustee expires on December 31, 2021 and his re-appointment will commence for a four-year term ending December 31, 2025; now, therefore, and

**WHEREAS**, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S.) provide that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; now, therefore, be it

**RESOLVED:** That Jan Washburn, and Oakland resident, is hereby appointed as a Trustee of the Alameda County Mosquito Abatement District Board, effective January 1<sup>st</sup>, 2022, for a four-year term ending December 31, 2025.
