A Report and Proposed Resolution Authorizing the City Administrator or Her Designee to Accept and Appropriate a Donation in the Amount of Ten Thousand Dollars (\$10,000) to the Oakland Police Department for the Acquisition of Patrol Canines, Valued at Approximately Four Thousand Eight Hundred Dollars (\$4,800) Each, for a Total Cost of Approximately Nine Thousand Six Hundred Dollars (\$9,600), for Use by the Police Department Canine Program, With the Remainder of the Funds to be Used to Offset Handler Training Costs and the Purchase of Canine Related Supplies and/or Services

SUMMARY

A resolution has been prepared authorizing the acceptance and appropriation of a \$10,000 donation from Mrs. Leone Baker. The resolution also authorizes the purchase of two (2) canines, with any remaining funds used to provide training and/or the purchase of canine related supplies and/or services.

FISCAL IMPACT

The \$10,000 shall be used by the Canine Program for the purchase of two Patrol Canines and to offset the cost of handler training and purchase supplemental supplies and / or services. Each Patrol Canine is valued at approximately \$4,800. Funds shall be appropriated to General Fund No. 1010, in the Canine Org.: 105625, Special Operations Program (PS13), in Project No.: P51800.

KEY ISSUES AND IMPACTS

The teams assigned to the Canine Program have been responsible for locating hundreds of criminal subjects, large quantities of illegal narcotics, and performed at numerous public demonstrations. These demonstrations have been conducted at neighborhood public safety fares, schools and senior citizen centers.

In addition, evidence recoveries by canine team personnel included 10 pounds of marijuana, 60 grams of cocaine, 2 guns, and \$20,000 in currency.

The new dogs will replace two police canines, Kato and Rambo, who are being retired.

SUSTAINABLE OPPORTUNITIES

Economic

Food, veterinary care, training and miscellaneous supplies for the Canine Programs Patrol Dogs are purchased locally.

Environmental

There are no environmental impacts related to the Patrol Canines.

Social Equity

The Police Department's Canine Program police officers and dogs are an approachable lawenforcement presence who concentrate their efforts on searches for criminal subjects, locating illegal narcotics, and providing public relations demonstrations. These dogs have a natural detection system, which enables them to locate hidden persons and evidence after a crime has been committed.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR HER DESIGNEE TO ACCEPT AND APPROPRIATE A DONATION IN THE AMOUNT OF TEN THOUSAND DOLLARS (\$10,000) TO THE OAKLAND POLICE DEPARTMENT FOR THE ACQUISITION OF TWO PATROL CANINES, VALUED AT APPROXIMATELY FOUR THOUSAND EIGHT HUNDRED (\$4,800) EACH, FOR A TOTAL COST OF APPROXIMATELY NINE THOUSAND SIX HUNDED DOLLARS (\$9,600), FOR USE BY THE POLICE DEPARTMENT CANINE PROGRAM, WITH ANY REMAINING FUNDS TO BE USED TO OFFSET HANDLER TRAINING COSTS AND THE PURCHASE OF CANINE RELATED SUPPLIES AND/OR SERVICES

WHEREAS, Mrs. Leone Baker has donated \$10,000 to a designated fund for the purpose of purchasing two Patrol Canines; and

WHEREAS, the Police Department needs to purchase and train two canines for the purpose of criminal apprehension, narcotics detection, officer safety and public demonstrations.

WHEREAS, one canine will replace Rambo, who is retiring after over 7 years of exemplary service to the Oakland community, with the other dog replacing Kato, who is retiring after 8 years of service to the Oakland community.

WHEREAS, this generous contribution will provide two (2) dogs which are needed by the Police Department Patrol Division, but for which current funds are not budgeted; now, therefore be it

RESOLVED: That the City Council authorizes the City Administrator or her designee to accept the donation of \$10,000 from Mrs. Leone Baker; and be it

FURTHER RESOLVED: That the money shall be appropriated to the Police Department in Canine Project (P51800) Fund: 1010, Canine Org.: 105625, in Special Operations Program PS13, for the express purpose of purchasing two Patrol Canines, at a cost of approximately \$4,800 each, for a total cost of approximately \$9,600, for use by the Police Department Canine Program; and be it
