

Informational Report on FY 2005-06 and FY 2006-07 Contracts within the

City Administrator's Higher Approval Limits, as set by the Purchasing

Ordinance (OMC Chapter 2.04)

SUMMARY

Per a previous City Council request, this informational report provides a listing of all purchases and contracts above the City Administrator's prior limits (\$50,000 for goods or supplies, and \$15,000 professional services), and below the City Administrator's new limits, as set by the recently revised Purchasing Ordinance (OMC Chapter 2.04). The new limits are: \$250,000 for contracts and purchase orders for supplies, services or a combination; \$150,000 for professional services contracts. The exceptions to this limit are contracts in four specific categories: 1) related to affordable housing; 2) Redevelopment Agency funded; 3) funded by voter-approved measures, and 4) related to information technology.

FISCAL IMPACT

Acceptance of this report will have no direct fiscal impact, as the funds required for these contracts were appropriated as part of the FY 2005-07 budget.

DISCUSSION

The City Council adopted Ordinance 12634 CMS amending the Purchasing Ordinance on December 7, 2004. The new Purchasing Ordinance (OMC chapter 2.04) states that contracts related to programs or projects that are included in the adopted Capital Improvement Program or Policy Budget can be approved by the City Administrator up to the following new threshold amounts: \$250,000 for any contract or purchase order for Supplies, Services or a Combination; and \$150,000 for any contract or purchase order for Professional Services. All contracts are still subject to the City's bidding requirements, purchasing rules and regulations.

As part of the FY 2005-07 budget adoption process, the City Council asked for an informational report showing contracts that fall within the City Administrator's approval limits. Attachment A shows all purchases and contracts above the City Administrator's prior limits (\$50,000 for goods or supplies, and \$15,000 for professional services) but below the new limits (\$250,000 for supplies, services or a combination, and \$150,000 for professional services). These contracts will be executed during FY 2005-07 without return to Council.
