**RESOLUTION AUTHORIZING REIMBURSEMENT FOR COUNCILMEMBERS-ELECT JANANI RAMACHANDRAN AND KEVIN JENKINS' COSTS NOT TO EXCEED \$1,400 PER COUNCILMEMBER FROM THE COUNCIL CONTINGENCY FUND FOR TRAVEL TO SACRAMENTO FOR ATTENDANCE AT THE LEAGUE OF CALIFORNIA CITIES NEW MAYORS AND COUNCIL MEMBERS ACADEMY FROM JANUARY 18, 2023 THROUGH JANUARY 20, 2023**

**WHEREAS**, Councilmembers-Elect Janani Ramachandran and Kevin Jenkins will be participating in the League of California Cities New Mayors and Council Members Academy being held in Sacramento CA, on January 18-20, 2023, and;

**WHEREAS**, City Council Resolution No. 82800 C.M.S approved by the City Council on June 1, 2010 requires that, when Councilmembers seek Council approval for using City funds for travel, their agenda materials shall indicate whether travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees and the source of City funding that will be used to cover the travel cost; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost for Councilmembers-Elect Ramachandran and Jenkins is \$625.00 in registration fees each, \$500.00 for lodging each, and \$237.00 per diem each for a total estimated costs of \$2,724.00, all costs within the City of Oakland's approved travel policies and procedures, and;

**WHEREAS**, Councilmembers-Elect Ramachandran and Jenkins seek City Council approval for the aforementioned cost to travel to Sacramento CA, to attend the League of California Cities New Mayors and Council Members Academy being held in Sacramento CA, on January 18-20, 2023; now, therefore, be it

**RESOLVED:** That all expenses incurred for said travel are hereby authorized.
