**WHEREAS**, Annie Campbell Washington has served as the Vice Mayor of Oakland since January 2016 and has been the esteemed City Councilmember for District 4 since 2015; and

**WHEREAS**, she also served as the Director of Operations & Special Projects at the Stuart Foundation in San Francisco and as Executive Director of the I Have A Dream Foundation in Pittsburgh, Pennsylvania; and

**WHEREAS**, Annie holds a Master of Public Policy degree from the Goldman School of Public Policy at the University of California, Berkeley and a Bachelor of Science degree in Industrial Management/Graphic Communications Management from Carnegie Mellon University in Pittsburgh, Pennsylvania; and

**WHEREAS**, Annie is the proud mom of Bahia & Quincy, and her fur-baby Georgie. Annie currently serves on the Board of Directors for the Alameda County Transportation Commission. She previously served on the Board of Directors for Safe Passages, the East Bay Agency for Children, Children's Fairyland, and Girls, Inc. Annie is an active parent in her children's PTA's; now, therefore, be it:
