Re: **Information From the Oakland Police Department Concerning the Annual Fleet Report**

### SUMMARY

In response to questions asked by the Finance and Management Committee on June 8, 2010, staff has prepared the following report concerning vehicles within the Oakland Police Department.

### KEY ISSUES AND IMPACTS

#### *Age of Vehicles*

The average age of vehicles within the Oakland Police Department is currently between 6.5 to 6.7 years old. At any given time there are approximately 30 patrol vehicles (per week) out of commission due to servicing and breakdowns.

#### *Number of Vehicles*

The current number of vehicles within the Department is sufficient; however, the quality of these vehicles is poor due to the mileage and age which requires more service and repairs as a result of constant breakdowns. The corporation yard provides the service and repairs at an average of 50 vehicles per week. The average use/age of a patrol vehicle (marked) is approximately 3 years; non patrol (unmarked) vehicles average 5 to 7 years.

#### *Vehicles in Rotation or Out of Service*

There are 328 vehicles assigned to the Bureau of Field Operation in various capacities:

- 142 assigned to patrol functions
- 26 assigned to the Crime Reduction Teams (CRT)
- 4 patrol wagons
- 11 SUV's assigned to command and tactical officers
- 13 pool cars
- 55 assigned to Neighborhood Enrichment Teams (NET) and Problem Solving Officers (PSO)
- 18 unmarked assigned to patrol command and tactical officers

- 16 unmarked assigned to Support Operations Division (SOD)
- 14 various trucks, vans, command posts assigned to SOD
- 29 civilian vehicles assigned to SOD

There are 76 various marked, unmarked, and civilian vehicles assigned to the Bureau of Investigations.

There are 54 various marked, unmarked, drivers training, animal control trucks, vans, and trucks assigned to the Bureau of Services.

There are 22 unmarked vehicles assigned to the Office of Chief of Police.

There are 22 civilian Neighborhood Services Division vehicles.


There are 26 various marked and unmarked pool vehicles.

There are 44 vehicles that have been taken out of service for various reasons.
