RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO GOLDEN BAY CONSTRUCTION, INC., FOR THE 8TH STREET STREETSCAPE IMPROVEMENTS PROJECT IN THE ACORN PRESCOTT NEIGHBORHOOD (PROJECT NO. P131610), FOR THE AMOUNT OF EIGHT HUNDRED FORTY-SIX THOUSAND ONE HUNDRED SIX DOLLARS AND FORTY-FIVE CENTS (\$846,106.45)

WHEREAS, on October 30, 2000, three bids were received by the Office of the City Clerk of the City of Oakland for the 8th Street Streetscape Improvements Project in the Acorn Prescott Neighborhood (Fund 9501, Organization 88919, Account 54920. Project P131610); and

WHEREAS, Golden Bay Construction, Inc., is the lowest responsible bidder for the project; and

WHEREAS, there are sufficient funds in the project budget for the work, and the project budget includes \$930,717 for construction of the work, and the engineer's estimate for the work was \$826,927; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now therefore be it

RESOLVED: That the contract for the 8th Street Streetscape Improvements in the Acorn Prescott Neighborhood is hereby awarded to **Golden Bay Construction, Inc.**, in accordance with the terms of its bid therefore, dated October 30, 2000, for the amount of Eight Hundred Forty **Six** Thousand One Hundred **Six** Dollars **and** Forty-Five Cents (\$846,106.45), and be it

FURTHER RESOLVED: The amount of the bond for faithful performance, \$423,053.22, and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for the amount due under the Unemployment Insurance Act, \$846,106.45, with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to enter into a contract with **Golden Bay Construction, Inc.,** on behalf of the City of Oakland and to execute any amendments, or modifications of said agreement, within the limitations of the project specifications; and be it

FURTHER RESOLVED: That all other bids are hereby rejected; and be it

FURTHER RESOLVED: That the City Clerk is hereby directed to post conspicuously forthwith notice of the above award on the official bulletin board in the Office of the City Clerk.
