## RECOMMENDATION

Staff recommends that City Council adopt a resolution authorizing the City Administrator, or her designee, to enter into professional services agreements in an amount not to exceed one hundred fifty thousand dollars (\$150,000.00) each with 1) Architecture Dimensions, 2) Devi Dutta-Choudhury, 3) Hibser Yamauchi Architects, and 4) Vargas Greenan Architecture for on-call architectural services over a period of three years; and adopt a resolution for professional services agreements in an amount not to exceed seven hundred fifty thousand dollars (\$750,000.00) each with 1) Byrens Kim Design Works, 2) Dougherty & Dougherty Architects, 3) Group 4 Architects Research, 4) MVE Institutional, Inc., 5) Muller Caulfield Architects, 6) Murakami & Nelson, 7) Noll & Tam Architects, 8) RPR Architects, 9) Shah Kawasaki Architects for on-call architectural services over a period of three years.

## EXECUTIVE SUMMARY

On-call professional services are needed to provide architectural and engineering services to support the City's Capital Improvement Program. Services are required for site and building assessments, conceptual planning, building programming, Americans with Disabilities Act (ADA) and code analysis, preparation of conceptual through construction design documents, cost estimating, construction support and other services. Typical projects include libraries, recreation and community centers, senior centers, restroom facilities, public safety facilities and other architectural related projects.

## OUTCOME

Approval of the proposed resolutions will award professional contracts to various architectural firms to provide design and engineering services to support the City's capital improvement program.

## BACKGROUND/LEGISLATIVE HISTORY

Public Works Agency (PWA) is managing many architectural projects in various stages. To deliver these projects timely and cost effectively, PWA utilizes on-call professional services contracts solicited through a competitive process in accordance with OMC Section 2.04.051. It is anticipated that many non-major capital improvement projects funded by capital improvement funds, bonds, and grants will utilize the on-call professional services. Additionally, unscheduled projects will occur throughout the three years and will also be able to utilize the on-call architectural professional service agreements. On-call architectural professional services agreements allow the City to promptly respond to and provide the necessary design services in an efficient and timely manner. The agreements will reduce the time and processes associated with selecting consultants on an individual project-by-project basis and thereby provide cost savings to the City. The City's past round of on-call architectural services agreements were approved in April 2007 and most contracts have been maximized.

The Tier I and Tier II submittal process was utilized to encourage and nurture smaller architectural consultant firms interested in doing business with the City of Oakland. Also, the two Tier process will prevent the smaller firms with less experience from competing with larger more experience firms. The Tier I fee category is typically intended for smaller sized firms with a lesser level of experience in the required types of public agency projects. The Tier II fee category is intended for larger firms with a higher level of experience in the required types of public agency projects. Each contract for Tier I will be for an amount not to exceed \$150,000.00 and each contract for Tier II will be for an amount not to exceed \$750,000.00 over a three-year period; the agreements will be managed by the Public Works Agency, Department of Engineering and Construction.

In March 2012, the City issued a Request for Qualifications (RPQ) for on-call architectural design services for various projects. Thirty-two (32) firms responded to the RFQ. A panel, comprised of a Landscape Architect, a member from the Office of Neighborhood Investment, and a member from the Bay Area Rapid Transit (BART) District Capital Improvement Department reviewed the proposals and recommended all six (6) of the Tier I proposers and fourteen (14) of the twenty-six (26) Tier II proposers to be short-listed for interviews based on the quality and contents of the proposals.

The short-listed firms were then interviewed and evaluated by the three panelists. The evaluation criteria for the interview included the following:

1. Relevant experience and strengths of the firm;
2. Organization of firm, availability of resources and capability to meet project schedules;
3. Qualifications of project team and project manager;
4. Meaningful responses to interview questions; and

5. Ability to provide high quality customer service to the City and the community.

### **ANALYSIS**

Based on the panel's evaluation, four of the Tier I firms and nine of the Tier II firms are recommended as most qualified to provide on-call architectural design services. The thirteen selected firms have the technical expertise to perform the work required, and clearly demonstrated their understanding of the technical complexities and regulatory issues involved in implementing public capital improvement projects.

Nine of the thirteen firms are certified local or small local businesses. All thirteen firms meet or exceed the City's Local/Small Local Business Enterprise (L/SLBE) program requirements and will be compliant with the City's Equal Benefits Ordinance. The Contracts and Compliance Unit has verified the L/SLBE information for each firm (see *Attachment A for Tier I firms and Attachment B for Tier II firms*). Aggregate participation levels are 64% for Tier I and 72% for Tier II.

### **PUBLIC OUTREACH/INTEREST**

The City's web-based procurement system iSupplier was utilized for distribution of the RFQ. The RFQ was formally advertised in newspaper circulations: The Oakland Tribune, San Francisco Chronicle and the Daily Pacific Builder. In addition, the RPQ was forwarded to the local professional organization, East Bay Architectural Institute of America, for posting.

### **COST SUMMARY/IMPLICATIONS**

Each agreement for Tier I consultants will be for an amount not to exceed \$150,000.00 and each agreement for Tier II consultants will be for an amount not to exceed \$750,000.00. The on-call architectural design services will be utilized for projects funded by various capital improvement funds, bonds, and grants such as Measure WW, Measure DD, Community Development Block Grants, State Department of Parks and Recreation grants, and others.

The approval of these contracts will not result in additional appropriation of funds. The services will be funded through appropriations of individual projects. Funds will be identified prior to the performance of the design services.

All firms exceed the requirements for Local and Small Local Business participation. The aggregate participation for Tier I is 64% and for Tier II is 72%.

### **PAST PERFORMANCE, EVALUATION AND FOLLOW-UP**

4. Vargas Greenan Architecture - This firm has never had a contract with the Public Works Agency.

#### Tier II:

1. Byrens Kim Design Works - This firm has completed two (2) task orders in the past year and satisfactorily completed the projects.
2. Dougherty & Dougherty Architects -- This firm has never had a contract with the Public Works Agency.
3. Group 4 Architects Research - This firm has not had a recent contract with the Public Works Agency in the past year, but has satisfactorily completed past projects.
4. MVE Institutional, Inc., - This firm has never had a contract with the Public Works Agency.
5. Muller Caulfield Architects - This firm has completed one (1) task orders in the past year and satisfactorily completed the project.
6. Murakami & Nelson - This firm has completed one (1) task order in the past year and satisfactorily completed the project.
7. Noll & Tam Architects - This firm has completed two (2) task orders in the past year and satisfactorily completed the projects.

8. Shah Kawasaki Architects - This firm has completed one (1) task order in the past year and satisfactorily completed the project.
9. RPR Architects - This firm has completed three (3) task orders in the past year and satisfactorily completed the projects.

### **SUSTAINABLE OPPORTUNITIES**

***Economic:*** The projects will generate business tax, sales tax, and other revenues for the City by those firms who work on the project. Local businesses will be utilized on the projects and will benefit directly.

***Environmental:*** Environmental factors and opportunities will be considered and incorporated to the extent feasible. Consultants will be required to consider the use of recycled materials in the products specified and to integrate other environmental, waste reduction and energy conservation opportunities.

***Social Equity:*** The proposed architectural design services for capital improvement projects will improve existing and extend the useful life of facilities or provide new City facilities and parks for public use.

Consultants will be required to design the City improvements in compliance with the physical access requirements of applicable accessibility codes and the Americans with Disabilities Act.

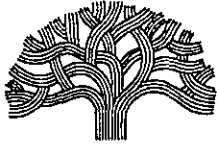

Per the request of the Public Works Agency, on June 5, 2012, July 17, 2012 and October 9, 2012, the City Administrator's Office, Contracts and Compliance Unit conducted compliance reviews of six (6) proposals in response to the above referenced project. Below is the outcome of the compliance evaluation conducted on October 9, 2012 for the minimum 50% Local and Small Local Business Enterprise (L/SLBE) participation requirement. Effective February, 2012, the City waived the 25% Small Local Business Enterprise (SLBE) requirement for certified local prime contractors competing for professional services contracts. In addition, firms are reviewed for compliance with the Equal Benefits Ordinance (EBO).

**WHEREAS**, professional architectural design services are needed to provide site surveying, site analysis, programming, design services and construction support services for various architectural related projects; and

**WHEREAS**, on-call architectural design services agreements allow the City to promptly respond and provide the necessary services in an efficient and timely manner; and

**WHEREAS**, unscheduled projects will also occur throughout the three-year period and will likely require architectural design services; and

**WHEREAS**, it is anticipated that various funded capital improvement projects will utilize the as-needed services agreements; and

**WHEREAS**, the City Council finds that services under contract will be temporary; and

**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, OR HER DESIGNEE, TO ENTER INTO PROFESSIONAL SERVICES AGREEMENTS IN AN AMOUNT NOT TO EXCEED SEVEN HUNDRED FIFTY THOUSAND DOLLARS (\$750,000.00) EACH WITH 1) BYRENS KIM DESIGN WORKS, 2) DOUGHERTY & DOUGHERTY ARCHITECTS, 3) GROUP 4 ARCHITECTS RESEARCH, 4) MVE INSTITUTIONAL , INC., 5) MULLER CAULFIELD ARCHITECTS, 6) MURAKAMI & NELSON, 7) NOLL & TAM ARCHITECTS, 8) RPR ARCHITECTS, AND 9) SHAH KAWASAKI ARCHITECTS FOR ON-CALL ARCHITECTURAL SERVICES OVER A PERIOD OF THREE YEARS**

**WHEREAS**, professional architectural design services are needed to provide site surveying, site analysis, programming, design services and construction support services for various architectural related projects; and

**WHEREAS**, on-call architectural design services agreements allow the City to promptly respond and provide the necessary services in an efficient and timely manner; and

**WHEREAS**, unscheduled projects will also occur throughout the three-year period and will likely require architectural design services; and

**WHEREAS**, it is anticipated that various funded capital improvement projects will utilize the on-call services agreements; and

**WHEREAS**, the architectural design services will be handed through the various individual projects and funds will be identified prior to the performance of the architectural design services; and

**WHEREAS**, the City conducted a competitive Request for Qualifications selection process; and

**WHEREAS**, twenty-six firms responded to the City's Request for Qualifications process for Tier II and nine most qualified firms were chosen to provide the services; and

**WHEREAS**, the City wishes to enter into a contract with each firm, and

**WHEREAS**, the City Council finds that the professional architectural design services are exempt from competitive bidding pursuant to Oakland Municipal Code Section 2.04.051 A; and

**WHEREAS**, the City Council finds that this agreement is for services of a professional nature; and

**WHEREAS**, the City Council finds that services under contract will be temporary; and

**WHEREAS**, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore, be it

**RESOLVED:** That the City Administrator, or her designee, is hereby authorized to enter into an Agreement each with

to provide on-call architectural design services; and, be it

**FURTHER RESOLVED:** That the total amount of the Agreement for each agreement is for an amount not to exceed Seven Hundred Fifty Thousand Dollars (\$750,000.00); and, be it

**FURTHER RESOLVED:** That for any work orders issued under this resolution requiring the use of any City General Purpose Fund money not already specifically appropriated by City Council to the project, the City Administrator shall return to the City Council for approval of the allocation of the General Purpose Fund money; and be it

**FURTHER RESOLVED:** That the contract term will be for three (3) years from the date of contract execution; and, be it

**FURTHER RESOLVED:** That the City Administrator, or her designee, is hereby authorized to approve any subsequent amendments to or extensions of said agreement with the exception of those related to an increase in total compensation or the allocation of additional funds, provided that such amendments or extensions shall be filed with the City Clerk's Office; and, be it

**FURTHER RESOLVED:** That a copy of the agreement will be on file in the City Clerk's Office and will be approved for form and legality by the Office of the City Attorney.
