#### **RECOMMENDATION**

Staff recommends approval of the attached ordinance amending Ordinance Number 13133 C.M.S. (the FY 2012-13 Master Fee Schedule, or "MFS"), to establish, modify and delete fees and penalties assessed by the Office of the City Clerk, The Administrative Services Department, the Oakland Police Department, and Parks and Recreation.

#### **REEASON FOR SUPPLEMENTAL**

At the July 2, 2013 Council meeting, Councilmember Brooks directed staff to bring back additional information regarding Oakland Police Department (OPD) Administrative Fee for towing, impounding, and releasing of vehicles towed or impounded and cost related to improper charging of the administrative fee.

Per OPD, if the stolen vehicle status can be verified with a police report and/or through the statewide Stolen Vehicle System at the time of vehicle release, the vehicle release fee is waived. There are very few OPD errors (less than 5%) that result in a refund as a result of erroneously charging the administrative fees.

The tow company charges tow fees and storage fees and these fees are paid directly to the tow company. Oakland residents have a 48-hr waiver of storage fees. In many occurrences, vehicle owners are able to recoup the tow fees if they process a claim through their insurance company.

AN ORDINANCE AMENDING ORDINANCE NUMBER 13133 C.M.S. (THE FY 2012-13 MASTER FEE SCHEDULE, OR "MFS"), TO ESTABLISH AND MODIFY FEES AND PENALTIES ASSESSED BY THE OFFICE OF THE CITY CLERK, THE ADMINISTRATIVE SERVICES DEPARTMENT, THE OAKLAND POLICE DEPARTMENT, AND THE OFFICE OF PARKS AND RECREATION.

WHEREAS, the City of Oakland periodically updates its Master Fee Schedule to account for general cost of living increases and program changes or other costs; and

WHEREAS, the fee modifications and additions proposed herein have been justified by the respective agencies and are identified in an "Agenda Report" dated June 19, 2013 to Deanna J. Santana, City Administrator, entitled "Report Amending the Master Fee Schedule".

WHEREAS, the City Council finds and determines that the herein-referenced modifications and additions are necessary to reimburse the City for the costs of performing the various municipal and regulatory functions; and

WHEREAS, a Public Hearing was held on July 2, 2013, to review the proposed fee changes; now, therefore

#### THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

Section 1. The Master Fee Schedule as set forth in Ordinance Number 13133 C.M.S., as amended, is hereby amended to modify and establish fees assessed by Citywide, the Office of the City Clerk, Administrative Services Department, the Oakland Police Department, and the Office of Parks and Recreation in Exhibit A, attached hereto and made a part hereof.

Section 2. This ordinance shall be effective on July 16, 2013 upon approval by the Council of the City of Oakland.
