

WHEREAS, three members are selected by the Mayor, two members are recommended by the Chairperson of the Finance and Management Committee, one member is recommended by each Councilmember, one member is recommended by the City Auditor, and one member is recommended by the Chairperson of the Community Economic and Workforce Development Committee: and

WHEREAS, the Honorable Mayor Libby Schaaf, upon the recommendation of the corresponding Councilmembers, appoints Travis George and Sarah Lee; now therefore be it

RESOLVED: That pursuant to section 601 of the Charter of the City of Oakland. the City Council hereby confirms the Mayor's appointment of:

Travis George to serve a three year term beginning October 3, 2018 and ending October 2, 2021 filling a seat previously held by Marguerite Fuller.

Sarah Lee to serve a three year term beginning October 3, 2018 and ending October 2, 2019.
