**ORDINANCE AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 C.M.S. ("SALARY ORDINANCE") TO AMEND THE TITLE OF BUDGET DIRECTOR TO BUDGET ADMINISTRATOR, REDUCE THE SALARY RATE FOR BUDGET ADMINISTRATOR, AND CREATE THE CLASSIFICATION OF BUDGET ADMINISTRATOR, ASSISTANT**

**THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:**

**Section 1.** Ordinance No. 12187 C.M.S. "The Salary Ordinance" is hereby amended as set forth below. Additions are indicated by underscoring and deletions are indicated by ~~strike-through~~ type; portions of ordinances not cited or not shown in underscoring or strike-through type are not changed.

**Section 2.** Effective as of March 25, 2017, the following classification is amended in Ordinance No. 12187 C.M.S. in the Unit ~~UK1.75.029~~ UK2.75.026 Pay Grade Table to read as follows:


