#### REASON FOR THE SUPPLEMENTAL REPORT

At the Rules and Legislation Committee of June 28, 2018, Committee Members requested a supplemental report be prepared for City Council review at the meeting of July 10, 2018. Specifically, members requested a status listing of proposed ballot measures for the November 6, 2018, General Municipal Election.

Staff compiled this information into *Attachment A* which contains a listing of proposed ballot measures that have been submitted to the Rules and Legislation Committee for scheduling in the previous months, measures that have been submitted to the City Clerk's Office by members of the public, and ballot measures approved for the Statewide General Election.

Nine ballot measures have been proposed and/or introduced by City officials, and two measures have been initiated through the public signature process. For those items introduced by the Mayor or City Council Members, the last scheduled City Council Meeting for the Council to approve the measure so it may appear on the November 6, 2018, General Municipal Election ballot is the special meeting of July 24, 2018.

The California Secretary of State has finalized the statewide propositions that have qualified for the November ballot. In total, 12 measures will be presented to voters for the Statewide General Election on November 6, 2018. That information has also been added to the listing in **Attachment A**.

The deadline to submit a ballot measure for the November 6, 2018, Alameda County General Election is August 10, 2018. According to County staff, at the time of submitting this report, no measure had been approved or qualified to be placed on its November ballot.
