INTRODUCED BY COUNCIL PRESIDENT PATRICIA KERNIGHAN

RESOLUTION AUTHORIZING COUNCILMEMBERS ABEL GUILLEN AND ANNE CAMPBELL WASHINGTON TO TRAVEL TO SACRAMENTO, CALIFORNIA TO ATTEND THE 2015 LEAGUE OF CALIFORNIA CITIES NEW MAYORS & COUNCIL MEMBER ACADEMY IN SACRAMENTO, CALIFORNIA FROM JANUARY 14 – 16, 2015

WHEREAS, Councilmembers Abel Guillen and Anne Campbell Washington wish to represent the City of Oakland at the 2015 League of California Cities New Mayors & Councilmembers Academy in Sacramento, CA from January 14, through January 16, 2015; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost per Council member of transportation is \$165.72 for Gas & Parking, \$338.00 for two nights of lodging, \$85.00 for three days of per diem, and \$550.00 for conference registration fees; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Councilmembers Abel Guillen and Anne Campbell Washington seek Council approval of the fore mentioned estimated costs to travel to Sacramento, CA to attend the 2015 League of California Cities New Mayors & Council Member Academy; now, therefore, be it


RESOLVED: That all expenses incurred for said travel are hereby authorized.
