**RESOLUTION AUTHORIZING AMENDMENT NO.1 TO THE AGREEMENT WITH HARZA ENGINEERING COMPANY FOR ADDITIONAL AS-NEEDED GEOTECHNICAL ENGINEERING SERVICES FOR AN AMOUNT NOT TO EXCEED \$50,000, FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$100,000**

**WHEREAS**, additional professional services are needed to provide prompt geotechnical analysis, site evaluations, subsurface investigations, and specialized laboratory testing for various projects which involve landslides, groundwater issues, soil mechanics, and pavement failures which mainly occur over the winter rainy season; and

**WHEREAS**, having consultants available and under contracts will allow the City to address and resolve these problems during the upcoming winter rainy season in a timely manner; and

**WHEREAS**, it will also reduce time and costs currently expended in selecting consultants on a project by project basis; and

**WHEREAS**, Council Resolution No. 74951 C.M.S. awarded an as-needed geotechnical engineering service contract to **Harza Engineering Company** for a not to exceed amount of \$50,000; and

**WHEREAS**, the City Council finds that the services provided pursuant to the agreement authorized hereunder are of a professional, scientific or technical nature; and

**WHEREAS**, the City Council finds that services under contract will be temporary; and

**WHEREAS**, Council finds that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

**RESOLVED:** That the City Manager is hereby authorized to enter into Amendment No.1 to the Agreement with **Harza Engineering Company** to provide additional geotechnical engineering services and other design related services to the Project Management Division of the Public Woks for an amount not to exceed \$50,000, for a total contract amount not to exceed \$100,000; and be it

**FURTHER RESOLVED:** That the City Manager, or his authorized representative, is hereby authorized to approve any subsequent amendments to or extensions of said agreement with the exception of those related to an increase in the total dollar amount of the agreement, provided that such amendments or extensions shall be filed with the City Clerks Office; and be it

**FURTHER RESOLVED:** That a copy of the agreement will be ~~on~~ file in the City Clerks Office and will be approved for form and legality by the Office of the City Attorney.
