

Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled matter arising from an incident on March 27, 2001, wherein it is alleged that officers of the Oakland Police Department falsely arrested the plaintiff.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended in the amount of Fifteen Thousand Dollars and No Cents (\$15,000.00), to be made payable to Jose Ortiz and Miles Washington, Esq., his attorney of record.
