

**RESOLUTION AUTHORIZING COUNCILMEMBERS NOEL GALLO, DAN KALB, AND LYNETTE GIBSON-McELHANEY TO TRAVEL TO SACRAMENTO TO ATTEND THE 2013 NATIONAL LEAGUE OF CITIES NEW MAYORS AND COUNCILMEMBERS ACADEMY FROM JANUARY 16 TO 18, 2013**

**WHEREAS**, Councilmembers Gallo, Kalb, and McElhaney seek Council approval to attend the League of California Cities New Mayors and Council Members Academy in Sacramento, California, January 16-18, 2013; and

**WHEREAS**, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$206, of lodging is \$200 for 1 night, of per diem is \$168 for 3 days, of conference registration fees is \$550 for Councilmember Gallo; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$125, of lodging is \$400 for 2 nights, of per diem is \$168 for 3 days, of conference registration fees is \$550 for Councilmember Kalb; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$125, of lodging is \$400 for 2 nights, of per diem is \$168 for 3 days, of conference registration fees is \$550 for Councilmember McElhaney; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

**WHEREAS**, Councilmembers Gallo, Kalb, and McElhaney seek Council approval of the fore mentioned estimated costs (for each) to attend the League of California Cities New Mayors and Council Members Academy, in Sacramento, California, January 16-18, 2013; now, therefore, be it

**RESOLVED:** That the Council hereby approves the above-described travel expenses for Councilmembers Kalb, McElhaney and Gallo to attend the League of California Cities New Mayors and Council Members Academy in Sacramento, California, January 16-18, 2013.
