RE: Informational Report on the Fiscal Year 2007-2009 Equipment Replacement

Plan

SUMMARY

The Public Works Agency (PWA) has proposed the purchase of 289 replacement vehicles and pieces of equipment for the City's fleet (*Attachment A*). Reliable, appropriate and efficient vehicles and equipment contribute to the delivery of all services within Oakland, ensures the safety of City employees, and contributes favorably to employee morale and retention. In addition, replacing vehicles and equipment supports the Mayor/Council FY 2007-09 strategic goal to improve efficiency and responsiveness to our residents.

FISCAL IMPACTS

Replacing overaged vehicles and equipment in a timely manner can save the City considerable funds by:

- reducing vehicle downtime and assuring vehicle availability for service delivery
- reducing operating and maintenance costs
- reducing the amount of funds expended on costly repairs due to age or overuse
- mitigate breakdowns
- take advantage of efficiencies built into newer, more technologically advanced equipment

The Equipment Division has identified 289 vehicles with life cycles ranging from 3 to 15 years that are overdue for replacement. Should the Council opt for a private-placement lease to fund the acquisition of these vehicles, the leases would be paid off over a period of ten years in declining semi-annual payments from approximately \$1,866,802 to \$633,026, respectively (Attachment B).

BACKGROUND

The Equipment Services Division of the Public Works Agency (PWA) is responsible for the maintenance of the City's active fleet, which is comprised of 1,379 vehicles and 323 pieces of other equipment that have a current total replacement value of approximately \$79,500,000. The Equipment Services Division is also responsible for working with City agencies/departments to assess annual vehicle and equipment needs.

In past years, the Equipment Division has worked closely with the Budget Office and Treasury Division to develop a limit for the replacement plan. With the FY 2007-09 budget cycle, however, financing for a replacement plan could not be finalized because of the deficit associated with the Equipment Replacement Fund (4100).

Prior to FY 1999-2001, the City historically paid for vehicle and equipment replacement on a pay-as-you-go basis. From FY 1995-1996 through FY 1998-1999, the City appropriated \$4,800,000 to the Equipment Fund each year for the replacement of vehicles and equipment. Over time, problems arose from this funding arrangement. With inflation and the rising cost of goods, the annual \$4,800,000 appropriation became insufficient to fund each year's replacements, resulting in deferring replacement of non-emergency vehicles and equipment. In addition, the borrowing of money from the Equipment Replacement Fund for other programs required the deferral of vehicles and equipment. As a result, by FY 1999-2000, the City had accumulated a \$28 million backlog of overaged vehicles and equipment.

In FY 1999-2000 the City Council and the Oakland Joint Powers Financing Authority approved a tax-exempt, private-placement lease of \$28,800,000 to finance the acquisition of 818 vehicles/equipment. During the FY 1999-2001 budget cycle, the City commenced the acquisition of the replacement equipment to eliminate the City's backlog of over-aged vehicles and equipment.

In FY 2001-03, the City Council and the Oakland Joint Powers Financing Authority approved a second tax-exempt, private-placement lease of \$14,900,000. Due to lower interest rates, the City's Treasury Division 1) refinanced the balance of the 2000 Master Lease at a savings of \$677,998; 2) lowered the lease borrowing for previously approved vehicles from \$16,970,000 to \$15,500,000, which resulted in interest savings of \$95,183, for a net value of \$88,053; and 3) financed the acquisition of 247 replacement vehicles and pieces of equipment.

In FY 2003, with less than one-third of the acquisitions completed, the then City Manager directed Equipment staff to freeze the acquisition of replacement vehicles pending the results of an independent review of the fleet. Staff performed the audit and reduced the size of the fleet by 126 vehicles (7% percent), from 1,830 vehicles and equipment to 1,704. Staff was not directed to resume acquiring replacement vehicles until 2005.

The 2000 Master Lease allowed the City to cover the debt service payments on the \$28,800,000 equipment lease financing through the annual Equipment Fund appropriation (\$4.8 million plus an additional \$1.1 million in annual contributions from the Equipment Fund balance through FY 02-03). Beginning with the 2002 Master Lease, the annual appropriation was insufficient to

cover the cost of the debt service, requiring larger than anticipated borrowing from the Equipment Replacement Fund.

KEY ISSUES AND IMPACTS

A regular, scheduled vehicle and equipment replacement program is important to agencies and departments. It ensures that reliable vehicles and equipment in good working order are available to assist in the delivery of essential services to the citizens of Oakland. Cars, trucks, tractors, and other equipment that break down frequently due to age or excessive use interfere with workforce planning and can lead to disrupted schedules and failed services. Good, working equipment that is appropriate for the tasks contributes to positive employee morale. All these factors combine to make a first class vehicle and equipment replacement program.

The vehicles identified for replacement in the FY 2007-09 plan range from one to nine years overdue for replacement, with the average being three to four years overdue. Priority has been placed on replacing overdue emergency response equipment first, e.g., marked and unmarked police patrol vehicles and fire apparatus.

SUSTAINABLE OPPORTUNITIES

Economic: Acquiring replacement vehicles creates opportunities for local vendor participation in providing vehicles and equipment for the City, increasing the City's sales tax revenue. As vehicles/equipment age, they become more costly to maintain and repair. Newer vehicles place less of a maintenance burden on City resources, and generally ensure greater vehicle availability for user departments.

Environmental: Replacing vehicles and equipment at the end of their service life with new vehicles results in a fleet that uses fuel more efficiently because of continuing advances in automotive/equipment technology, thereby improving air quality. New diesel-powered vehicles comply with federally mandated diesel engine emissions standards which significantly reduce particulate matter (PM) emissions. Several vehicles are slated for alternative fuel power, which will further reduce harmful emissions.

<u>Social Equity</u>: New vehicles operating within low-income neighborhoods, which contain at risk and sensitive populations (i.e., children, seniors, and those with elevated asthma rates) will contribute fewer pollutants, improving air quality.
